- **Club Colors:** Red and black
- **Club Outfits:** Anything in the club colors
- **Club Badge:** The badge is a white bow, with a red button in the middle of the bow. Members who transferred from Hampton Promenaders have 'Hampton Promenaders' engraved on their badge. Please always wear your badge to the dances, on banner raids and retrievals, and for demonstrations. If you need to order a club badge, please see the treasurers.
- **Membership Responsibilities:**
 - All members, please bring snacks to all dances.
 - Every member should show their loyalty and support of Buttons & Bows by attending as many dances as possible, participating in banner raids and retrievals, and helping where needed.
 - Every member should participate in making guests welcome; do not let anyone sit alone or not get to dance (this includes the callers' and cuers' partners). If guests ask questions you are unable to answer, please find someone who can provide the answer(s). Greetings and friendliness do not stop at the door!

**History of
Buttons and Bows of Lakeland
Square and Round Dance Club
Lakeland, Florida**

The time was 1952. The location was the Old Armory (near Lakeland Regional Health) in Lakeland, FL. The Denim and Calico Club started a class led by Frank and Buddy Hawkins. Two students in the class – Howard Parrish² and Paul Noble - became interested in calling right away.

The new dancers graduated but Denim and Calico did not have room to take in the new dancers (can you imagine?). Frank Hawkins told Howard and Paul that he would “teach you boys to call, and you can take this class and make a new club.” The callers for Denim and Calico were Frank Hawkins, later Jube Tack, and sometimes Ed Bossing from Florida Southern College.

Our own Larry and Dorry Clevenger learned to dance in one of the Denim and Calico classes around 1952. Larry later served as president of that club. Larry³ and Dorry have been members of Buttons and Bows since 1958.

In 1952, Howard and Paul, along with Mel Clark, formed their own club (Buttons and Bows) and shared the calling for some years at the Old Women’s Club on Lake Morton in Lakeland.

Denim and Calico’s callers eventually retired and the club folded in the late 50s. In those days, the dues were only \$10 per couple per year, and membership was limited to “80 married couples”.

(NOTE: Due to the loss of earlier files, there is a gap in the Club’s information. The above are the memories of Larry and Dorry Clevenger and Evelyn Parrish, widow of the first caller, Howard Parrish)

On Saturday, October 27, 1973, Buttons & Bows moved to Sanlan Ranch Campground in south Lakeland in 1975, and then the dance site moved to the Mulberry Civic Center.

In 1979, the club adopted the current white “bow” badge with the button etched in the middle, which was created and made by the late Chuck Leamon (a former caller for Buttons & Bows).

The dances relocated to the new Strawberry Square Dance Center in Plant City in January 1980.

Blue and white were the club colors in 1980. Red and white became the colors in 1983.

Before the '80s, the late Marty Martin (co-founder of Strawberry Square in Plant City) was the club cuer. In the early '80s, Jim Runnels became the club cuer until he transferred to Vero Beach. Approximately 1983, Charlie Lovelace became the club cuer and he continues to cue for the club to this day.

Another move came in 1981 when they relocated to the Mulberry Civic Center again, and they danced continually on the second and fourth Saturdays of the month until November 27, 2004.

In 2002, there was a celebration at the Lake Mirror Auditorium in Lakeland to celebrate the 50th anniversary of the club. There were approximately 280 dancers and spectators in attendance with Art Springer calling and Charlie Lovelace cueing. All past presidents and former members were invited. An article appeared, with a picture, in the Lakeland *Ledger* regarding this special occasion. Representatives from the West Coast Square and Round Dancers Association, the Florida Federation, guest callers and cuers and one charter member of the club attended.

November 27, 2004, found us dancing on the beautiful hardwood floor of the 1920's era Magnolia Building in Lakeland, and the City of Lakeland would sponsor the club. The only opening on the calendar at that time for the club to hold their dances was the second and fourth Tuesdays of the month.

Buttons and Bows of Lakeland is a member-run club, led by a Board of Directors and operates under its own set of Bylaws. For many years, the club has provided a fabulous spread of finger foods at every dance. This club is unique because of the many social events held during the year. Each year the club has four special events where the club members do something away from the dancing such as dinner theaters, luncheon cruises, tours, plays, concerts, and an annual picnic. Forming committees, having planning meetings and going on the actual event allows everyone to get to know each other and form new friendships which is challenging to do at a dance. We are an extended family for many of our members who have moved here from the north or who winter here.

A merger of the Hampton Promenaders of Auburndale and Buttons and Bows of Lakeland occurred in April 2011. Up until that time, the Buttons and Bows dues structure was that each member paid a large lump sum at the beginning of the year and did not pay at the door. With the merger, members started paying less dues at the beginning of the year and paying a reduced amount at the door.

Then in 2011, red and black became the new club colors. This change of colors was due to the merger of Hampton Promenaders. Buttons & Bows was red and white and Hamptons was black and white.

After the merger and with the start of square dance lessons (after several years of no lessons in Lakeland), the club took in 37 new members in 2011.

The merging of Buttons and Bows and Hampton Promenaders was the only option available to save two failing clubs that would have eventually folded. The taking in of 37 members has been a significant boost in not only the club's treasury but it has also boosted the morale of all the members. We can only get bigger and better!

In 2012, we shut down for the summer due to low attendance at the dances. In 2013, we decided to go back to being a year-round club.

Art Springer, our long-time club caller, retired on December 28, 2014, which was a dance night and his final night of calling. With Art's retirement, we went to guest callers for every dance instead of having a club caller for the second dance of each month.

Buttons & Bows is one of two clubs in Florida named 'Buttons & Bows'; therefore, we refer to our club as Buttons & Bows of Lakeland to avoid confusion.

Buttons & Bows and their members have participated in numerous events over the years such as

BY-LAWS OF
THE BUTTONS AND BOWS
SQUARE AND ROUND DANCE CLUB OF LAKELAND

Article I **Name**

Section 1. This organization shall be known as "The Buttons and Bows Square and Round Dance Club of Lakeland", a non-profit organization.

Article II **Objective**

Section 1. The purpose of this organization is to bring dancers together for fellowship and proficiency in the art of modern western style square dancing and round dancing, and to provide a medium for expressing this fellowship by holding regularly scheduled dances where square and round dancing are engaged in by members.

Article III **Membership**

Section 1. **Membership**

Square dancers and/or round dancers, married or single and non-dancing spouse or companion shall be eligible for membership in this organization.

Section 2. **Classification**

There are two classes of membership

(a) **ACTIVE MEMBERS**

Members shall pay dues for the entire calendar year. These members agree to take their turn as greeter/registrar and server and subscribe to the conditions, objectives and ideals set forth in the By-laws and policies adopted by the Executive Board.

(b) **ASSOCIATE MEMBERS**

Callers and cuers will be eligible for associate membership in the Club; however, they will be non-paying and non-voting members but eligible to attend all club functions.

Section 3. New Members

Prospective members shall complete an application and submit it to any officer.

Section 4. Revocation of membership

- A. This organization reserves the right to revoke the membership of any member whose actions are unbecoming or contrary to the policies adopted herein. Revocation shall be enforced by the Executive Board.
- B. Any person attending a dance while intoxicated or who displays unbecoming conduct shall leave said dance at the request of any officer present.

Section 5. Dues and Fees

- A. **Active** – New membership dues are \$15, plus the cost of the badge, per person. Annual renewal dues of \$15 per person must be paid by December 1st for insurance purposes.
- B. **Associate** - Callers and cuers are non-paying members but eligible to attend all club functions.
- C. Admission fees for dances are \$5 per person for each guest and \$4 per person for each member. This will be adjusted according to the needs of the club by approval of the General Membership.
- D. As a courtesy, visiting callers and cuers are admitted free.

Section 6. Insurance

Liability and supplemental medical insurance will be provided for all members through the United Square Dancers of America (USDA) square dance insurance program.

Article IV Officers

Section 1. Officers

The officers of this organization shall be President, Vice-President, Secretary and Treasurer and they will serve as the Executive Board.

Section 2. Election of Officers

- A. A nominating committee shall be appointed by the president in January. This committee shall prepare a slate of officers that shall be presented to the membership at a called meeting in March. At this time further nominations of candidates, who have agreed to accept, may be made from the floor.
- B. The method of voting shall be at the discretion of the voting members present.
- C. Only club members in good standing may be elected.
- D. Officers will be elected by a majority vote of the members in attendance.

Section 3. Term of Office

The term of office shall be for one (1) year and shall commence June 1 and will continue until May 31.

Section 4. Removal of Officers

Any officers elected or appointed may be removed from office at any time, with just cause, by a majority vote at an Executive Board meeting.

Section 5. Duties of Officers

- 1. President:
 - 1. The president shall preside at all regularly scheduled dances and meetings. He is empowered to call special meetings at his discretion.
 - 2. The president will call an annual meeting of the membership during the month of March.
 - 3. The president shall appoint all committee chairmen and the representative(s) to the West Coast Association, as set forth in Article VII. He may establish such additional standing and temporary committees, as he deems necessary, with the approval of the Executive Board. He shall be ex-officio member of all committees appointed by him.

4. The president shall keep members regularly informed of all club activities and decisions made by the Executive Board.

2. Vice-President:

- A. In the absence of the president, the vice-president shall preside at all dances and meetings, and shall assist the president when requested.
- B. Should it be necessary to fill the office of president, the vice-president, if agreeable, will automatically move up, otherwise, the Executive Board will appoint a new president.
- C. The vice-president shall be responsible for negotiating and signing all contracts for the hall, callers, and cuers.
- D. The vice-president shall be responsible for membership communication to include notifying members of illnesses and deaths, membership meetings, and other information the Executive Board deems needs to be communicated to the members. A committee may be established or the task can be assigned to an individual(s).

3. Secretary:

1. The secretary shall keep accurate and complete minutes of all meetings and handle correspondence.
2. The secretary shall be responsible for sending cards to club members in the event of illness or death.
3. The secretary shall be responsible for ensuring the reporting of club news each month to the *Bow & Swing* magazine, and any other publications, which may benefit the club. A committee may be formed or the task may be assigned.
4. The secretary shall be responsible for notifying the *Bow & Swing* and the *West Coast Dancer* of the new dance listing contact person at the start of each new dance season.
5. At the beginning of each new dance season, the secretary shall be responsible for notifying the Florida Federation webmaster of the new officers, schedule, and any other information that needs to be updated.

4. Treasurer:

- A. The treasurer shall collect all dues and monies constituting the revenue of this organization, keep an accurate record thereof, and pay all legitimate bills.
- B. The treasurer shall keep an accurate record of the membership.
- C. The treasurer is required to make a written financial report at the end of each quarter.
- D. The treasurer's books shall be audited by an auditing committee prior to the start of each new dance season, attended by the newly elected president.
- E. The treasurer shall be responsible for ordering and dispensing badges for new members.
- F. The treasurer shall be responsible for submitting the insurance roster and premium payments at the end of the calendar year for the upcoming year and submitting addendums as new members are taken into the Club.

Article V

Dances

Section 1. Regular dances shall be held on the second and fourth Tuesdays of each month, unless otherwise ordered by the Executive Board.

The dance hours and/or location will be designated by the Executive Board and communicated to the membership.

Section 2. Special dances, including the anniversary dance, may be called as the president and a majority of the Executive Board may designate.

Section 3. The club colors shall be red and black. Club colors shall be worn for banner raids and retrievals and any other special occasion as designated by the Executive Board.

Section 4. Square dance attire at all dances will be optional.

Article VI **Board of Directors**

Section 1. The Board of Directors shall consist of the Executive Board as set forth in Article IV, Section 1, the standing committee chairmen and representative(s) of the West Coast Association as set forth in Article VII, and the immediate past president.

Section 2. The Executive Board, of which the president is chairman, shall hold a meeting as deemed necessary by the president. A financial report shall be emailed or mailed to each of the Board members once a quarter. The Board of Directors shall present recommendations to the organization for action when deemed necessary or as our By-laws dictate.

Article VII **Committees and Representatives**

Section 1. The standing committee chairmen shall be appointed by the president and said committees shall be: Servers, Greeters/Registrars, Theme Dances, Special Events, Banner, Membership, and West Coast Representative(s).

Section 2. Duties of Committees

1. Membership

A. **Picture Directory** - A member will be appointed to maintain the membership directory, ensuring that it is kept current. Copies will be provided to each member as soon after the close of the annual membership renewal period as possible and to new members as they join the Club.

B. **Recruitment** - Schedule and promote new dancer classes each year. Coordinate with the caller/instructor to establish a list of qualified angels for the class.

2. Servers

A. The chairman shall coordinate with the Greeters/Registrars Chairman to assign dates for each member to work as a server. The president and treasurer will be exempt from assignment due to the responsibilities of their respective offices. A copy of the schedule for all assignments will be provided to each member and posted on the club bulletin board. It shall be the chairman's responsibility to remind

the members of their obligation. If a member cannot be present on the assigned date, it shall be the member's responsibility to trade with someone and notify the chairman.

- B. The chairman shall be responsible for keeping kitchen supplies and refreshments stocked at all times and turn in a bill to the treasurer for reimbursement.
- C. The servers are responsible for making beverages, setting out refreshments, and cleaning up the kitchen.
- D. The servers, greeters, and registrars will work together to break down the hall and return supplies to the storage room.

3. Greeters/Registrars

- A. The chairman shall coordinate with the Servers Chairman to assign dates for each member to work as a greeter/registrar. The president and treasurer will be exempt from assignment due to the responsibilities of their respective offices. A copy of the schedule for all assignments will be provided to each member and posted on the club bulletin board. It shall be the chairman's responsibility to remind the members of their obligation. If a member cannot be present on the assigned date, it shall be the member's responsibility to trade with someone and notify the chairman.
- B. The assigned greeters for each dance shall greet guests as they arrive. The registrars shall collect dance fees, have dancers sign the appropriate book, have the caller/cuer book signed, and record members present. Money collected shall be turned over to the treasurer.
- C. The servers, greeters, and registrars will work together to break down the hall and return supplies to the storage room.

3. Theme Dances

- A. The Chairman will present a schedule of theme dances, including the anniversary dance, to the Executive Board for final approval.
- B. The chairman shall be responsible for decorating for our theme dances, and may establish a committee to assist with the decorating.

5. Special Events

The chairman shall be responsible for the coordination of special events throughout the year. The number, type and schedule of events to be held yearly will be determined by the general membership. These events bring dancers together for fun and fellowship. These events may be attended by club members, guests, and callers/cuers.

6. Banner

The chairman shall be responsible for arranging for dancers to attend dances of other clubs in the area to promote good relations, collect banners, and retrieve our own banner when necessary.

Section 3. West Coast Association Representative(s)

The president shall appoint a representative(s) to the West Coast Association, other than a current West Coast Association officer or county representative, who shall act as liaison between the club and the West Coast Association. The member appointed shall attend any meetings and shall work with the Association in an effort to further promote and improve square and round dancing in the area.

Article VIII Parliamentary Authority

Section 1. Robert's Rules of Order, Revised, shall be the final authority as to parliamentary procedure, insofar as they do not conflict with any provision of these By-laws.

Article IX Amendments

Section 1. These By-Laws may be amended at any called meeting of this organization by affirmative vote of two-thirds of the members present.
