2010 Florida State Convention Fundraiser

A very popular fundraiser we started at the Fall Fun Fest a few years ago will again be held this year. The bidding on and selling of themed baskets became popular for Christmas gifts and everyone wanted to do them again this year!

Although we hold this fundraiser at the Fall Fun Fest, the proceeds are donated to the 2010 Florida State Convention.

Individuals, clubs and organizations may donate one or more themed baskets to be bid on at a silent auction Saturday night of the Fall Fun Fest. The baskets will be awarded and presented that night for you to take home. Every year there are new ideas! What can you come up with?

Below are the instructions that have been or are being given to the past participants:

1. Minimum retail value of basket should be included. (If basket is worth more

- than \$50 retail, please split into two baskets.)
- **2.** Gift certificates should be good for 6 months.
- Gift certificates should accommodate anyone within the West Coast Association Area.
- **4.** Gift certificates should not require purchase to receive the gift.
- 5. Bring baskets to the Fall Fun Fest Dance on Friday November 7, 2008, no later than 6:30 pm. If you cannot bring the basket to the dance at the specified time, your club should make arrangements with Fred & Jan Smith at 863-668-9128 for pick-up a few days prior to the dance.
- **6.** Shrink or cellophane wrap each basket. This will ensure all items stay with each basket.
- **7.** Baskets should pertain to a selected theme and be aesthetically pleasing.
- 8. Theme basket items may be embellished or adjusted to suit your style and taste. Creative and exciting baskets yield a successful auction.
- Notify Fred & Jan Smith of your theme selection so that duplicate themes may be avoided. Some ideas for themes are listed below, but you are welcome to create your own.
 - **a.** "Holiday Basket" choose any holiday for your theme.
 - **b.** "TLC Basket" foot wash, "Calgon", candle, bath beads, manicure set, lotions.
 - c. "Picnic Basket" picnic table set from \$1 store has great checkered table cloths, Mosquito spray, out door fun games, Frisbee, ball.
 - d. "Laundry Basket" bleach, powder (non scent), fabric softener, hangers, dryer towels.

- e. "Family Fun Basket" popcorn, soft drinks, candy bars, nuts, etc.
- f. "Baking Basket" put everything into a large plastic bowl, minimuffin pan. All purpose flour, baking powder, baking soda, chocolate chips, etc., put in a couple of recipes.

National Press Release #4

The Bid Session at the 58th NSDC

The bid session at the 58th National Square Dance Convention® will take place in the beautiful Terrace Theater at the Long Beach Convention Center, just prior to the keynote speaker, the morning of Friday, June 29, 2009. The participants will be competing for the convention for the year 2013. Thus far we have conventions planned for June, 2010, in Louisville, KY, and in June, 2011, in Detroit, MI. At the 57th National Square Dance Convention®, held recently in Wichita, KS there were two excellent presentations made for the June, 2012 convention. The presentations were made by the City of Spokane, WA and the city of Oklahoma City, OK. The mayor of Oklahoma City spoke as a representative for that city and he said that if his city would have the convention in 2012, he'd learn how to square dance. That apparently did not influence the judges to vote his way and the City of Spokane, WA will host the convention in 2012. We have recently learned that the city of Oklahoma City will again be one of the parties bidding for the Convention of 2013. There is time for another city to announce that they will be competing for the 2013 convention, but even if it is just that one city making a presentation, it will be an opportunity for everyone to see what Oklahoma City has to offer.

Camping at the 58th NSDC

RV Camping for the 58th National Square Dance Convention® is available awaiting your reservation! The RV camping is right at the Long Beach Convention and Entertainment Center, so it will be very convenient for your coming and going to the activities of the convention. Really neat that you won't need a bus pass, huh? The RV camping is dry, with electricity provided. There is a four night minimum. The cost is \$55.00 per night, which is a real good deal compared to staying in one of the Long Beach hotels. When you send in your registration long form with requested RV space, you will receive a profile to fill out. These spaces will be assigned on a first come, first served basis. If you plan to camp together with others, you will need to arrive together. When you sign up for the Route 66 tour, you will be able to start your camping on June 22, as that night is reserved for the Route 66 tour participants, and those with June 23 tour events scheduled. All other camping starts on June 23, 2009.

Education at the 58th NSDC

Besides all the dancing, we will provide a multitude of educational opportunities for you while at the 58th National Square Dance Convention[®]. The Vice-Chairman of Organizations is Glenda Stults. Glenda will present the Organizations Round Table, Showcase of Ideas, Publications Display, Reports & Statistics, and the Bid Session. The Organizations Round Table is a two-

hour panel meeting that will allow an exchange of information of interest to square dance organization leaders. The Showcase of Ideas is an opportunity for all square dance organizations to put their information on display. National and international square dance clubs and associations will be represented, as well as CALLERLAB, CONTRALAB, ARTS and USDA. The Publicity Committee will collect publications as part of their recordkeeping to attend the press breakfast. Those publications will be provided to the Vice-Chairman of Organizations to use in the publications display. Reports Statistics will be needed for the Education Committee final report. Information such as attendance and start/end times for all education programs, such as seminars, panels, clinics, bid session, etc. will be recorded and tabulated. The bid session will take place on Friday morning at 9:00 AM in the Terrace Theater. Bidding cities will be bidding on the 62nd NSDC, to be held in the year 2013.

Don Orsbern is the Vice-Chairman of Panels, and he plans to present eleven panels over a three-day period. Our panels are an audience-listening activity conducted in a classroom setting. Three to six persons serve as a panel of knowledgeable leaders, discussing a given topic, with an additional panel member serving as a moderator.

Seminars are also an audience-listening activity and are presented in a classroom setting with one or more persons providing a presentation. Linda Hoffman is the Vice-Chairman of seminars, and she will present 21 seminars over a three-day period.

Sound at the 58th National Square Dance Convention®

Sound for the 58th National convention will be great! We will be using standard square dance equipment and will be providing hearing enhancement equipment necessary. There is no plan to use any house sound from the Long Beach Convention Center. The equipment will be rented and our Sound Committee will handle setting up and monitoring the sound the convention. The Sound durina Committee will consist of professionals from our activity.

The Vice Chairman of Sound is Phil Farmer. Phil has been a caller for over 30 years. He has worked on many national, state and local conventions in both technical and supervisory roles. Phil has a full committee in place. Phil's Assistant Vice Chairman is Rod & Gail Shuping. Rod has been calling for many years and has assisted in sounding many state conventions and local festivals. Director of Square Dance Halls is Skip & Kay Stanley. Skip has called in several states during the past thirty years of calling and worked out sound problems in many types of halls. Director of Round Dance Halls is Bev Oren. Bev is a noted Round Dance Cuer in Southern California and several other states. She has helped with sound at several state conventions. Director of Other Dance Halls is Donna Lake & Ron Krefet, Donna is a noted Country & Line Dance instructor in Southern California. She has a good understanding of the needs of special dance Director of Non-Dance Halls groups. (Education/Panels/Seminars) is Byron and Alanna Yoshimura. Byron is a caller in Northern California. His understanding of equipment makes him the perfect choice for the Sound Committee. Director of AfterParties is Vic & Shauna Kaaria. Vic is a popular caller/instructor in California. He has worked with many types of equipment over the years, and will quickly adjust to any special requirements that sometimes arise at the after-parties.

As you can see, each committee member has a good understanding of the needs and necessary equipment that would be required of each venue. They have performed at and assisted in sounding many local festivals, as well as state and national conventions. We look forward to providing some of the best quality sound you have heard at a national convention.




I know that a lot of you enjoy "bidding" on things and this seems like a really unique quilt, so I thought you might like a chance to make a bid.

If you are unable to attend the dance and want to bid on the quilt, you can email gasatter@bellsouth.net and submit your bid. Bids will be accepted by email until midnight Thursday, September 25th. Please include your name, full address, phone number and bid amount.

The bidding starts at \$75. The bids and times received will be logged in so that if there is more than one winning bid, the winner will be the first bid received.

BMI/ASCAP Licensing

I'm sure you've seen BMI/ASCAP before and you've probably wondered what it is and what it means. You've probably also heard that it's some kind of licensing for callers and cuers.

When you book callers and cuers for your dances, do you ensure that they have BMI & ASCAP licenses? It might be a good standard procedure to request a copy of their licensing card along with their signed contract.

I did some research on the internet and found that CALLERLAB has a concise article that answers all the questions, so below is a reprint of the article.

When is a license needed by the caller or cuer, rather than the club?

If the caller or cuer runs dances or weekends on their own, they will need a license for themselves. Callers and cuers can obtains licenses through the licensing organizations, join CALLERLAB, or get a license through CALLERLAB. BMI and ASCAP aren't set up to deal with individual callers or cuers, but they'll license a club for about \$22 per dance each – if they buy a year's worth of licenses in advance.

Joining CALLERLAB gives you both licenses, plus liability insurance, plus access to CALLERLAB's support and education services. Or you just can get a license from CALLERLAB without becoming a full member. Being licensed through CALLERLAB covers the caller or cuer when calling or cueing club dances and weekends, their own dances and weekends, and calling or cueing at all festivals except State and National Conventions. Those conventions must get their own licenses. Callers are also covered if they do rounds or Country Western dance as part of their overall square dance program.

If clubs are responsible, why do they want the caller to have a license? Not all clubs belong to dancer federations, so there's no good way for clubs to deal with BMI & ASCAP as a group. When the issue arose, club leaders got worried. BMI & ASCAP were threatening legal action, and the club leaders would be personally liable for hefty

copyright penalties. The idea of paying \$20,000per song is pretty frightening! CALLERLAB's deal with BMI & ASCAP solved the problem of license cost – but a club is only safe if every night's caller has a license. So to protect themselves, clubs have started to ask all their callers to be licensed.

Who is responsible for having a license?

Anyone who performs or plays copyrighted music needs a license. Normally, the event's organizer is responsible for obtaining the required licenses. For commercial concerts, that's the promoter. For commercial trade shows, it's the tradeshow organizer or individual booth holder. For square dances, it's the dance organizer. Most dances are club-organized, so clubs are.

How did BMI and ASCAP get involved in square dancing?

Over the past 40 years, BMI and ASCAP have turned their sights to square dancing several times. But there was never an easy way for them to track down square dance clubs for licensing and enforcement. Then, in 1990, they discovered S/D publications, which made it easy to find clubs. They mailed out about 4000 contracts to individual clubs and callers. This made people realize their exposure, and caused much concern.

There was another problem. Clubs are small, but BMI & ASCAP are big. So BMI & ASCAP offered their standard deal: \$22

each per dance, payable a year at a time in advance. For many clubs, that'd have been devastating – but small clubs had no way to negotiate for better terms. And new clubs would face an impossible up-front expense.

In an effort to avoid the unreasonable expense that BMI and ASCAP would impose on square dance clubs CALLERLAB & ROUNDALAB approached them to negotiate a more satisfactory licensing arrangement. BMI & ASCAP agreed to allow licensing of members of these organizations rather than payment of the license fee by individual clubs – on the condition that *all* US members be licensed.

US Performance-Rights Organizations

In the United States, there are three "Performance-Rights organizations" They act as agents to collect royalties that are owed to composers for the performance of their music.

BMI – Broadcast Music. Inc. represents mainly composers who work in the radio, television, and movie industries.

ASCAP – The American Society of Composers, Artists, and Publishers is the oldest copyright licensing organization in the U.S. It represents such composers as Irving Berlin and George Gershwin.

SESAC – SESAC started out representing gospel music and European composers; more recently, they've branched out into popular music.

Why is there licensing?

It's illegal to play a copyrighted song in public without the author's permission – a "license". It's absurd to each author to license songs individually (imagine the paperwork!), so they formed BMI & ASCAP, who do it for them.

Caller Contracts

Did you know there is a standard CALLERLAB approved caller contract to be used when you negotiate contracts with the callers for your dances?

I just found that the form was revised on September 12th so I am attaching it to this issue for your use.

The form doesn't say anything about cuers and I don't find anything on the Roundalab site about a contract for them, so I guess you can change the contract wording to use it for cuers.

I would recommend that everyone use this standard contract so that you are comfortable that everything is covered that should be.
