A Class Act from Start to Finish

Caller Paul Place founded the Die Hard Square Dance Club in Schweinfurt, Germany 30 years ago while he was stationed there serving in the U.S. Army. Thirteen Central Florida dancers, most belonging to the Whirl and Twirl Square Dance Club in Orlando attended the Die Hard's 30th Anniversary Dance on May 31, 2008. Paul was scheduled to be the caller at this Anniversary Dance, but was unable to attend due to poor health.

This spring Paul was diagnosed with incurable cancer. This is a terrible loss to us, his loving family, his local clubs, and to all square dancers. Paul has given up his five square dance clubs in the Central Florida area, and has moved back to Alabama to be close to his family.

Paul returned to Central Florida and called his final two square dances at the Whirl & Twirl Square Dance Club on July 9, and July 11, before permanently retiring from square dance calling.

Paul looked great and his calling was topnotch; he did not even miss a beat of "No Shoes, No Shirt, No Problems", while being wrapped in toilet paper onstage by enthusiastic dancers. Both performances were outstanding, although heart breaking for all those in attendance, especially when Paul ended Friday's dance with "The Cowboy Rides Away".

On Wednesday, we had 15 squares of dancers, including 16 first time visitors to

Whirl & Twirl, 6 visiting callers, and many more repeat visitors. On Friday we had an additional 16 first time visitors making over 18 squares of dancers, the most I have ever seen in that hall. After Paul's final dance, a long line of callers and dancers formed to wish Paul well, thank him for coming, and to bid him a fond farewell.

We love you Paul!

They do not cover cost even though the vast majority of work is done by volunteers who do the work for the love of the activity. Actually all, local, state and national publications do it for the love of the activity, not the profit. In short, buy advertising, support those who do advertise and especially, say thank you to the publishers, editors and volunteers who make it all happen.

To go or not to go, is this a Question?

Recently someone sent an anonymous email to Penny Green in reference to her article on closing down your club or organization during the Florida State Square & Round Dance Convention. The email reads:

"Just to let you know...There are more square dancers that cannot attend the convention, than can attend. One of the main reasons is financial. I am a square dance caller, for more than 45 years. I will NOT cancel our dance, during the conventions. More than 75% of our dancers cannot afford the total cost of attending the convention. Therefore, why should we cater to the convention by closing down our club, when the majority will not be able to attend it? I have not, and will not, close down our club, just so that a few of our dancers can attend the convention. Those who want to go, will go. Those that do not want to go, will still have a place to dance during the convention. Therefore, I wish you would not try to make those that cannot attend the convention ashamed for not going."

As a long time supporter of the Florida State convention I would like to respond to this anonymous caller. First I agree that attending a convention can be costly. If someone registers early they have to pay the fee of \$25 for a weekend of entertainment and fun. Second, if gas goes to \$5 a gallon, a 200 mile round trip drive will cost about \$50.00. If you choose to stay at a hotel, it could cost you an extra \$80.00 per night. This is almost \$250.00 for the weekend. You can pay much more if you like. Instead of a budget restaurant, you can dine upscale and pay \$100 per meal. Instead of a budget hotel, (most of which serve a nice breakfast) you get a nice suite at a hotel for \$300.00 or \$400.00. You could choose to just come for one day, and have no hotel bill. I admit this is higher than ten years ago, but I feel that it is still a reasonable fee for attending a get together with over a thousand dancers, callers and cuers. I will admit, the tone of your email makes me wonder two things. First do you mention or even promote the Florida State Convention? Second, as you are concerned about the ability of your dancers to pay, are you offering them a discount or free dances during the year? The second question is somewhat facetious as our activity is as expensive or inexpensive as we choose to Dancers can still buy recycled make it. clothes, or in some cases not even dress up for the dance. Dancers can still dance for an entire evening for less than the cost of a movie or a trip to a restaurant. Dancers can also attend a Square Dance Convention for far less than the cost of any of the business conventions that most professionals have to attend. And I must add this, Square and Round Dance Conventions are far more fun than any professional seminar or continuing education session that I have ever attended.

National Singles Dance-A-Rama

The 38th National Singles Dance-A-Rama was last weekend (Labor Day Weekend) in Nashville, TN.

Early reports are that the registration INCREASED with 672 dancers in attendance! That may not seem like many but I personally like small groups; when the group is too large you don't get to see everyone. But in this day and age an increase in registrations is something to celebrate! I haven't heard yet how many were from Florida.

I understand there was a last minute change on one of the callers as Tim Crawford was unable to come across the border; probably the same issue as before regarding him working in the U.S. Luckily the Committee was able to book another caller at the last minute to fill in for Tim.

The 39th Dance-A-Rama will be in Davenport, Iowa. I will be receiving flyers shortly and will start distributing them as soon as I can.

FundraisingfortheFlorida State Convention

Previously each of the five Florida associations (Central, Northeast, Northwest, Southeast and West Coast) rotated taking turns hosting the Florida State Convention every five years. So five years in advance each association knew which convention they would be hosting and five years in advance they started the fundraising for their convention.

In 2010 this will change, in that the convention will truly become a state convention and will no longer be hosted by a particular association. The Federation will appoint a couple, two individuals or an individual to chair the convention and each association will be responsible for fundraising within conducting their association. Therefore, each association will be conducting fundraising every year.

For West Coast Association's contribution to the fundraising for the 2010 State Convention, International Dining Packets are being sold. These packets contain cards/coupons good for 12 visits per restaurant for a buy one entrée get one free. These particular cards/coupons are honored at numerous restaurants in the Polk County area.

The cost of one packet is \$35 and they are good for one year. The current inventory expires August 31, 2009; there are only a few left and the price has been reduced to \$30 each.

If you are planning to come to the Fall Fun Fest in Bartow, which isn't very far from Lakeland, the Winter Festival and the 2009 Florida State Convention, you will have an opportunity to get a lot of use out of these cards/coupons.
