The first change will be a new location for the West Coast Folding/Business Meetings. We were "forced" out of the Barksdale Center along with Temple Twirlers and Spinning Wheels due to a rent increase.

USDA Square Dance Insurance

It's that time of year again! It's time to send in your renewals for the USDA Square Dance Insurance!

The insurance year is from January 1 – January 31 of each year; but due to the huge volume of renewals at this time of the year, you need to start sending in your renewals NOW so that you don't have a lapse in coverage. Your paperwork has to go through so many people (WC insurance chairman, Florida Federation insurance chairman, USDA insurance chairman) before it even reaches the insurance company to be processed.

Like everything else, there is a price increase this year of \$.20 per dancer for a total premium of \$4.45 per dancer, which is still pretty darn cheap considering the coverage you receive.

What coverage do you receive you ask?

- \$1,000,000 combined single limit of liability for bodily injury and property damage per occurrence (subject to a \$100 property damage deductible per claim) while participating in scheduled and sponsored dancing activities.
 \$100,000 limit for damage to premises rented by you.
- \$10,000 Usual and Customary Accident Medical Expense, including Dental \$10,000, Accidental Death Benefit \$10,000, Accidental Dismemberment Benefit (loss of both hands, both feet, sight of both eyes, or any combination thereof), \$5,000 Accidental Dismemberment Benefit (loss of one hand, one foot, sight of one eye).

NOTE: Coverage is excess to any other valid and collectible medical insurance covering the same accident. Coverage provided for covered medical expenses, incurred within 52 weeks of the accident up to \$10,000 for all eligible expenses as stated in the Policy.

Technically a dancer isn't a club member until they pay their dues; so when you have at least 11 members who have renewed their membership or joined your club, submit their premiums then. This will ensure that you do not have a lapse in your liability coverage. As more members renew or new members join, submit their names and premium payments.

Are you aware that if someone sues your club for injury or property damage and you don't have liability insurance, that each and every member of your club is liable? Don't you agree that \$4.45 per dancer is pretty darn cheap?

If your club has decided that they do not require this insurance because they are in a community that has coverage through their HOA, please be aware that you are not covered when you go on banner raids or do demos; you will be covered by the USDA Square Dance Insurance.

If your club has decided that they do not require this insurance because they feel they are covered by the caller's insurance; this is not true if you have contracted the caller and/or cuer to call for your club. Their insurance only covers them; not you the dancer and again you aren't covered when you go on banner raids or do demos.

What could happen on a banner raid or at a demo? Someone could fall and hit their head; someone could break an arm, leg, shoulder, hip; there could be an accident on the way. Accidents and injuries can happen anywhere at any time.

If your club is not participating in the USDA Square Dance Insurance program, you might want to re-consider your decision or lack of action.
