**Dick Chase** – cuer in southwest Florida – had a cancerous tumor removed from his lower abdomen last week. No other details available at this time. If you would like to send cards, his address is 513 Crampton Lane, N. Ft. Myers, FL 33903-2607.

**Danny Miller** – caller in Auburndale – was diagnosed with Adult's Coates Disease in his left eye a couple of years ago and has been receiving injections and lazar treatments. I then went for cataract removal and implant but now they want to do more surgery. From what I could find

on the internet, Coates Disease “is a progressive condition of the retinal capillaries which [usually] occurs in children and young adults, usually males. Commencing typically during the first decade of life, it is gradual in progress and affects central vision, usually in only one eye. (©2010 Royal National Institute of Blind People). Stephen **Bigelow** – caller in northeast Florida, shared this update on his wife, **Marie**. “Praise the Lord. A week has come since she was in to the hospital and she is still at home. Marie is on the oxygen machine almost all the time, but she is getting used to it. She wants to try shorter times without it so she can eventually go out without the tanks and go dancing. It is very much appreciated! This next week is a non chemo week so maybe she will have some energy to go out some. Keep your prayers going.”

**Update as of Monday, January 18<sup>th</sup>:** “Another week started with a doctor’s appointment and has gone downhill from there. She went to get a blood gas and a chest x-ray. The blood gas showed that her lungs are not doing their job giving the oxygen to her red blood cells. That is the reason she is so tired and lethargic all the time. Then Dr Buckley called with more bad news. Her red bloods cells are at a critical level and she is getting another blood transfusion on Wednesday. They are also delivering another oxygen machine to the house on Thursday; this one cannot deliver the amount of oxygen saturation it needs to. Its maximum is 4.5 l/m and she now needs 5.5 l/m. Thank you for the thoughts, prayers and cards.” (Reprint from Northeast Association’s Joys & Concerns 1/18/10)

**Update as of Saturday, January 23<sup>rd</sup> :** Marie had 2 units of blood on Wednesday at St Vincent's. The last time she had a transfusion she was up and dancing the next day. It was like an energy boost, but that didn’t happen this time. On Thursday she had a High Definition CT scan of her chest to see if they could determine what those three nodules are in the lungs. Friday she and Stephen went to see Dr Buckley and have him stop this chemo. It is causing too many problems. She is seeking a three week break and try a different chemo regime. She is tired of being tired all the time and sad that she cannot dance and see the friends from so many years. Please keep her in your prayers as her battle continues. As many of you know, **Jean Lee** (caller and dancer of Cocoa, FL) has been dealing with some medical issues for several months. She’s had all the tests the local doctors and hospital have ordered and the decision had been made that she was going to Mayo Clinic in Jacksonville hopefully for a diagnosis, prognosis and treatment plan.

She and Dick had an appointment for Wednesday, Dec. 23<sup>rd</sup> for an evaluation with the Dept. of Urology. On Dec. 30<sup>th</sup>, she had a radiology CT biopsy of a lymph gland in her lower abdomen. Although she had hopes to have heard news regarding her tests results, the Christmas holidays and vacation plans of her doctor delayed she and Dick learning of any results until last week.

Jean sent out this message a few days ago. "Well, I heard from the Doctor this evening and now I wish I hadn't. Bad news in that the cancer is back and the source is unknown, so we will go to Mayo next Tuesday for some tests, then see the Doctor on Wednesday and as I understand it also start chemotherapy on Wednesday. This wasn't the outcome that I that we were hoping for but it is what it is. That's all I know for now.

## Fall Colors Dancing

Some of you may remember reading about our exciting trip to California last June as we **danced our way across America**. We are Jerry and Donna Robey of Gainesville, Florida where we dance with the Grand Squares of Gainesville under the leadership of our home caller Lonnie Ligon. We are sharing this wonderful adventure because we truly believe in the benefits of dancing with a variety of callers and clubs. This exchange is good for Square Dancing as a whole, and helps to make us better dancers as a couple. The United Square Dancers of America (USDA) have a super program to encourage this exchange. It is called the USA Traveler Program. By the time we returned from the National Square Dance Convention in Long Beach, CA last Summer, we had danced in a total of 40 states in twelve months.

The USDA Traveler Program is designed to promote visitation between dancers in all 50 states. It encourages visitations of square dancers to regular club dances, festivals and state or national square dance conventions across state lines and around the United States. Of course the goal is to dance in all 50 states. A badge and a bar are awarded to the dance couple, at no charge to them, after they have visited at least 12 states. Additional different colored bars are awarded as follows: 12 states – Red Bar; 24 states – White Bar; 36 states – Blue Bar; 48 states – Silver Bar; and finally 50 states; Gold Bar. In addition, any participant who visits 48 or 50 states is awarded paid admission(s) to the next National Square Dance Convention.

This is where our Square Dancing adventure picks up. We had not yet danced in New England and we thought what better time than Fall when the Autumn Leaves are at a peak of color. Using the National Square Dance Directory on line as well as State square dance web sights which we found on the Western Square Dance web site, DOSADO.COM, we were able to build an itinerary which allowed us to dance in all the New England States in a period of less than three weeks. At each stop we were warmly received and offered the hospitality for which square dancers are famous. By the time we returned home from this adventure, we had covered almost 4,000 miles and danced with clubs in 9 more states, bringing us to a total of 49 states in 15 months. And now, with Hawaii being the only state remaining, we are looking forward to dancing at the 45<sup>th</sup> Annual Aloha State Square and Round Dance Festival in Honolulu Hawaii in January of 2010. We will report on this adventure upon our return.

One of the highlights of our trip to New England was the opportunity to meet many new friends and dance to some outstanding callers. One couple comes to mind, as they too were dancing their way through New England as a part of the USDA Traveler Program. They were Oliver and Andrea Kuester from Dusseldorf, Germany. We actually met up with them and danced together in three states: Newport, Delaware; Westerly, Rhode Island; and Unionville, Connecticut. The Fall colors were reaching a peak the first week of October as we drove through the beautiful mountains of Vermont and New Hampshire. The Fall colors were especially brilliant in the White Mountains of New Hampshire. In addition, we were able to experience history first hand as we visited Washington DC and the capital, Philadelphia and constitution hall where the Declaration of Independence was signed, and Boston where we visited the old North Church and the home of Paul Revere.. Of course, we had to have our Lobster Dinner along the coast of Maine. On our return to Florida, we drove through the outer banks of North Carolina and visited Kitty Hawk where the Wright brothers had their historic flight in 1903.

All in all, this trip was another exciting adventure. We encourage other square and round dancers to include dancing in your vacation plans. It's easy to do, and makes traveling much more interesting and fun as you interact with locals on the dance floor rather than just visiting the typical tourist destinations. This way, you really get to experience America up close and personal through the people you meet along the way.

We will be at the 59<sup>th</sup> National Square Dance Convention in Louisville, KY this June 23-26, 2010. We hope to see many of you there. As you make the drive to Louisville, we encourage you to connect with other square dancers along the way and begin your quest for the coveted USDA Traveler Award. Happy Dancing.

The United Square Dancers of America, the national square dancers organization, has a \$1000 college scholarship available for a youth square dancer somewhere in America. The Founders' Memorial Youth Fund Scholarship is presented each year to a deserving high school senior or college freshman who has shown their dedication to the promotion and perpetuation of the total square dance movement, including square dance, round dance, contra and clogging.



Application deadline for this merit-based scholarship is February 1st. The recipient of the scholarship will be announced in June at the USDA's Annual Board of Directors meeting held in conjunction with the National Square Dance Convention. (Go Louisville!!)

Each application must be signed by the President of the USDA member affiliate from the applicant's geographic area. Applicants will also need to write a short essay on the topic "the impact square dancing has had on my life" to submit with their application.
