FCA Members: Please pay your dues to the FCA Treasurer ASAP. The membership year is November 1 through October 31. You do have sufficient time to remit your dues. If you do not pay by Dec. 31, you will have the reinstatement fee to pay in addition to the dues to retain membership after Dec. 31. If you choose to rejoin after the reinstatement period, you will be a new member.

## Have you ever wondered about the different levels of callers in the Florida Callers Association?

**Green**: new member's entry to FCA; usually last

one year.

White: second level; normally they call at the annual clinic and are evaluated by at least three white badge or silver badge members. If they pass the evaluation, they are "promoted" to white; has full voting privileges and can hold office.

Silver: callers who have called in Florida 25 years and are a member of FCA.

Life: callers who have called in Florida for 50 years and are a member of FCA.

# Florida Callers Association President's Message

It really has been a PRIVILEGE to serve as resident of the FCA. At times, I admit, I had many "second thoughts" but in reality, the fine officers kept me and issues in perspective. I want to thank Bob Poyner (Immediate Past President), Bob Stern (Vice-President), Rod Barngrover \*(Treasurer) and Bill Boyd "Secretary" for the fine work and giving me guidance. I would do it

all over again with these officers. Thank you, gentlemen. In accordance with the By-Laws I cannot continue in this office.

Many Florida callers choose not to belong to the FCA. I respect their reasons why. Some, chose not to belong because of their perception of favoritism to friends. Their concerns may have been valid on occasion in the past. I have seen it myself, but not now. Things have changed to reflect equality for all members and potential members. Some callers still want to live the old way, but that way of doing business has been going by the wayside the past few years. The FCA has been moving in a positive direction with attitude of equality for all members and growing our activity.

The FCA has new By-Laws and tax exempt status with the IRS all in the name of equality for all current and future members. The equality is guaranteed in the By-Laws. Any deviance to the By-Laws is wrong and unfair to the rest of the membership and WILL be under scrutiny of the IRS in the event of any complaints. In the past few years, the FCA has progressed to these attainments. I am proud to have been part of this movement.

So, I ask all Florida callers to in the FCA. I ask all callers to be BMI/ASCAP licensed to protect the clubs (or you) to play your music. VERY IMPORTANT...Clubs or any sponsor, I ask you to make sure EVERY CALLER IS LICENSED as you will be covered to have copyrighted music played at the dance. ASK THE CALLER FOR PROOF! In addition, the clubs should put in their contracts that the caller will licensed at the time he/she will be calling and using copyrighted music<sup>1</sup>. Some clubs have taken that provision out of the contracts and that is wrong and dangerous to their own well being. These statements are not my opinion, but plain legal fact.

Over the past months, I brought out subjects of teaching, "Thinking outside the box", bragged about how "first class" we are in formality and callers improving their skills to be relevant in the modern square dance world. All of these aspects can be done at the same time by changing teaching times and orders for a mobile population of Florida, learning definitions, recruiting differently while keeping the elegance of traditions. With only 10% of the square dance world left, we have to be thoughtful and inventive to advance our activity.

To the new FCA Board members, your jobs will be simple...follow the By-OLaw (even if you don't agree with every requirement). I had a great board and their next one will be also. I will be a cheerleader!

## State Conventions

It is becoming very critical that we fill the position of general chairman for the 2019 convention. This position needs to be filled now so that they can also learn the ropes by being the assistant general chairman for the 2018 convention. This position can be filled by one couple, two couples, a solo or two solos, someone from the Florida Callers Association, the Round Dance Council of Florida, or the Florida Square Dance Campers as well as the Federation.

There is a Convention Procedures document which provides you with valuable information on what to do and there is also a timeline document that provides you information on when everything needs to be accomplished. There are also numerous past convention chairman to serve as advisors.

Regarding the 2018 convention...

There are several positions that still need to be filled: Dangle Dances, Entertainment, Grand March, Hospitality / Security, Program Ads, Publicity / Promotion, Vendor Chair, Ways & Means, W/M Central, W/M Northwest, and W/M Southeast.

The responsibilities of each of these positions are as follows:

- 1. Dangle Dances create dangle dance themes in coordination with the convention theme, schedule callers to call each dangle dance, work with Suzie Q Creations to design a dangle for each theme.
- 2. Entertainment arrange for entertainment in the evenings musical, dance demonstrations, etc.
- 3. Grand March coordinate lining up everyone for the Grand March.
- 4. Hospitality/Security coordinate the schedule of volunteers to greet at each of the entrances
- 5. Program Ads coordinate with each of the associations regarding the renewal of ads and the purchase of new ads for their respective areas. You <u>do not</u> have to live in Lakeland to fill this position. All of the ads are sent to the program booklet chairman.
- 6. Publicity/Promotion write press releases for the *Bow & Swing*, each of the association newsletters, local newspapers, etc.
- 7. Ways & Means coordinate with the convention chairman as to what fundraisers will be done and make arrangements for them.
- 8. Ways & Means for Central, Northwest and Southeast The state ways & means chairman makes the arrangements for each fundraiser and each of the associations needs a person to handle raffle ticket sales for their area.

We are not only facing the loss of dancers but also of workers. If we can't get volunteers to help put on these conventions, then we won't be able to continue having them.
