

TIP...

When sending an email with two or more names on your distribution list, the list should be inserted in to the bcc: (blind carbon copy) field. This ensures that no one is able to read your distribution list. If you insert the list in the To: or CC: (carbon copy) fields, everyone receiving the email will be able to read, copy, or use your distribution list. Insert your name in the To: field. This will help reduce the amount of spam we receive.

Editor's note: I know I'm ageing myself here but, bcc: is an old time expression from when we used carbon paper to make copies instead of a copier or printer. No one, other than the sender, can see the distribution list. CC: is carbon copy and is used for the names of people you want to receive the email for informational purposes only and everyone can see that they received a copy.

West Coast Association Distinguished Service Award

Purpose: To recognize a member(s) of the West Coast Square & Round Dancers' Association (WCSRDA) who has given service to the WCSRADA above and beyond the average dancer.

Committee: The committee shall consist of the five most recent recipeints of the award. Each year a new member will come on and the longest service will resign (unless someone else has to resign). They will elect a chairman from within

A quorum, a simple majority, is required to transact any business. This committee will review all nominations and select a winner by vote of the majority attending the meeting. The recipient(s) will not be revealed until the presentation.

Nominations: Any WCSRDA member may make nominations. Nominations will be submitted in the form of a resume. The resume shall include, but not limited to:

- 1. Number of years dancing
- 2. Number of years member of WCSRDA
- 3. Club membership
- 4. Offices held or holding at all levels. List the special contributions which you believe qualifies the nominee for the award.

Nominations shall be submitted no later than October 15th.

Presentation: The award will be presented annually at the Fall Fun Fest

Florida Square Dance Hall of Fame

The Hall of Fame was organized to honor dancers, callers, cuers, publishers, teachers, organizers, promoters and/or vendors for their contributions made to the dance activity **statewide**.

The Hall of Fame became a reality due to the work of Chet and Julia Vetter, Mori and Phyllis Sogolo, Art and Martha Springer and Marty and Birdie Martin. The first inductees were made May 19, 1983 at the state convention. The square dance hall at Strawberry Square became the permanent home of the Hall of Fame at a grand opening dance held on December 4, 1983.

At the State Convention, new members are presented with a small plaque to keep and a larger plaque is installed at Strawberry Squares Hall for public viewing. As of the State Convention in the year 2017, 90 inductees have been installed in the Florida Hall of Fame. These inductees

consist of dancers, callers, cuers, publishers and vendors. Some have qualified in two categories.

Display cases for past presidents of the Florida Federation of Square and Round Dancers, the Florida Callers Association, and the Round Dance Council of Florida have been provided by the Hall of Fame Committee. Each of the five area associations have a plaque displaying persons from their area who have been honored as person or couple of the year. An additional plaque lists the state convention general chairman, caller chairman, and cuer chairman for each of the state conventions.

The Hall of Fame is financed through funds derived from state conventions. The three sponsoring associations, Florida Federation, Callers Association, and the Round Dance Council, each contribute one-third (1/3) of the expenses.

The Selection Committee is a group of dancers, callers, and cuers from every area of the state and both sexes are represented. These are known only to the Hall of Fame Committee and not to each other. Members of the Selection Committee must have been active in the Florida dance activity for at least 10 years, have visited and danced in a number of areas within the state and be knowledgeable of what is going on. Voting is done in secret by sending resumes & ballots to each voting member; ballots are completed and returned to the Hall of Fame Committee Chairman without revealing the name and address of the voter. The ballots are opened in the presence of a quorum of the Hall of Fame Committee.

CRITERIA

The Hall of Fame is seeking individuals or couples whose efforts have affected the majority of the state of Florida.

Nominees must have a minimum of **ten years statewide involvement** with the Florida square and round dance activity. Their contributions must encompass the **entire state of Florida**, not just one or two areas. This should require unselfish dedication of time and labor. Being an area president, Federation president, caller/cuer association president and/or convention chairman is not enough. The fact that one is nominated is a very high honor whether they enter the Hall of Fame or not.

Nominating Resume

Preparing a nominating resume will take some time and investigation to make it complete. Talk to other dancers, callers and/or cuers for dates, places, and times the nominee was involved in statewide participation. Follow the who, what, when, and where rule as you investigate and prepare the resume. **The more information submitted, the better**.

Once the resume is finished there are two ways in which to present the information to the Hall of Fame Committee. The resume may be submitted to the board of directors of any of the five

associations, callers association or cuers association. The area or association board of directors will review the resume and vote to reject or pass it on to the Hall of Fame Committee. The resume may also be sent to the Hall of Fame Committee chairman.

Resumes must be received by the Hall of Fame Committee by November 1st **of each year.** It is suggested that any association not submit more than two resumes for consideration per year.

The Hall of Fame Committee shall meet, review all resumes presented, and vote by secret ballot, to forward such resumes to the Selection Committee for the final vote.

By submitting the resumes on or before November 1st gives the Committee time to review the resume(s) and submit them by mail to the Selection Committee for final consideration in time for presentation at the Florida State Convention.
