# Health and Sympathy

It is with great sadness that we report to you that **Phyllis Kent** passed away earlier this month at the age of 87. . Marlene spoke with her son Robert at length this morning and asked that he bring us up to date. What you will see is the struggle that many have when dealing with the final illness of a loved one.

The last time we heard from her son, Phyllis had just been moved to a new facility. At day 60, Woodlands felt that she was no longer progressing so she was tested to confirm that diagnosis. Specifically, they felt she had "plateaued" with her physical therapy, which means she was not responding well, not improving. It meant they might have to discharge her.

Her mental condition was deteriorating and there was no explanation. The physical therapist thought perhaps mom had suffered damage from the accident, damage that had not manifested itself until this time. The nurse felt it was a urinary tract infection, as this as this has been known to cause disorientation. After consulting with her physician, she was admitted to Holy Cross Hospital where she could be tested for both brain damage and urinary tract infection. The cat scan showed that she had two tract infections and they began treating her for those. During this time, Phyllis was getting weaker as she couldn't eat.

Holy Cross wanted to discharge her but no facility would accept because they didn't have long-term care insurance and they only had 30 days left with Medicare. She was finally admitted to St. John's Hospital. St. John's was going to admit her to a skilled nursing facility and as she improved, she would be transitioned in to assisted living.

On Saturday morning, March 1<sup>st</sup>, Phyllis was moved to St John's. On Monday morning, her son received a call from the Florida Medical Hospital emergency room stating that she had quit breathing at St. John's. She was put in intensive care and she was being treated for pneumonia. For the next three or four days they continue to treat her. Phyllis was very weak, the doctors were telling her son that because of her weakened state, and because she had been in hospitals so long, they didn't know if they could save her. They suggested if they were able to save, there would be considerable quality of life issues.

Her two sons were with her to the end. She went peacefully and comfortable and with no pain. Her son said she went out fighting and went out with love.

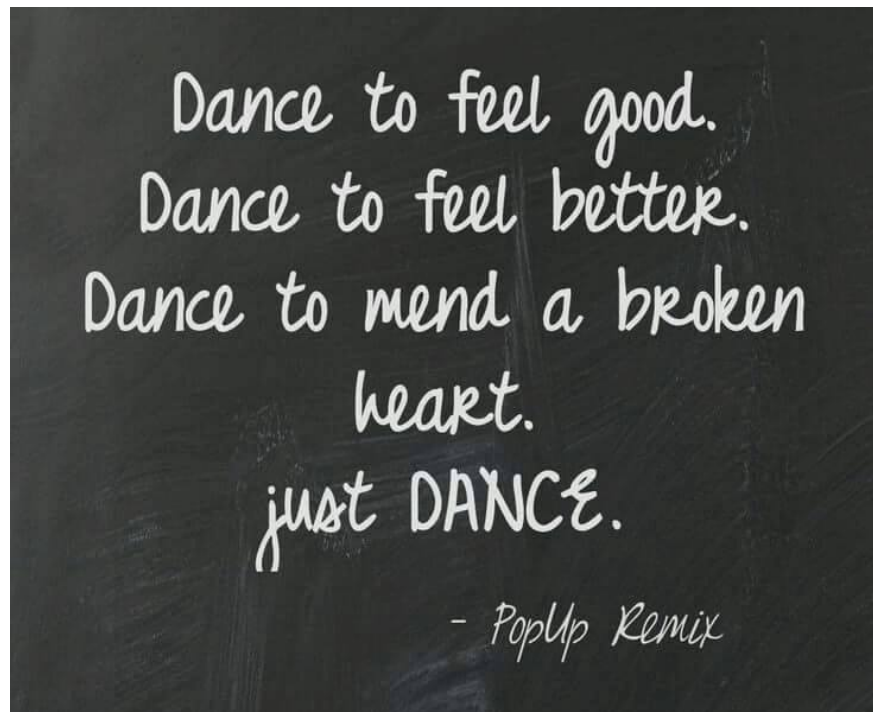
Phyllis was a cuer in southeast Florida, a member of the Round Dance Council of Florida, and was president of the Council in 1994.
