Suzanne Walker Hays Brown, 82, widow of Charles Kenneth Brown, II, passed away Thursday, November 28, 2019, at her daughter's home.

Born on July 13, 1937, in Pittsburg, PA, she was the daughter of the late Fredrick Hays and the late Betty Hutchinson Hale. Mrs. Brown was a member of Grace United Methodist Church and the Junior Women's League. She was an avid square dancer and a past president of the Florida Association of Square Dancers. Mrs. Brown enjoyed crafting, puzzles, sewing, and watching the Hallmark channel.

Survivors include three children, Denise Forehand (Cameron) of Georgetown, Heidi Rueger (James) of Evansville, IN and Pamela Sherman of West Virginia; six grandchildren, Amanda Taylor, Jacquelynn Sherman, Billie Taylor, Brandon Rueger (Priscilla), Blake Rueger and Caleb Freyer; and one great grandchild, Lincoln Rueger.

We received word of the passing of **Marge Carter**, a retired cuer from Columbus, Ohio. After several days of researching and emailing various people, the following information is for your review.

*"Marge Carter's brother, Bob Nuessle, was one of the first callers to introduce Western Square Dancing in Ohio. He "coaxed" Marge for seven years before she and Charlie "gave in" and finally took square dance lessons in 1959. In 1961 they took their round dance lessons from Dave & Martha Martin and Bob & Millie Lerch. They became good friends with both couples and enjoyed getting together with the Martins in their home or in the Carter's home to work out new dances from cue sheets. When the Martins and the Lerchs decided to retire about 1962 - 63, the Carters took over their round dance group and named it the "Marlers". Twenty two couples were in their first round dance beginners' class in 1964. There were no round dance "leaders' schools" as such at the time, but the Carters went to Dance-a-cade, Round-a-Cade, Canada-Cade and other round dance festivals in order to dance and learn new routines.*

*Marge and Charlie taught at several National and State Dance Conventions and were on the staff several years at Fontana Village, a resort in the Smokies, for the Spring and Fall "Fun Fest" and for "Accent on Rounds". They cued in the Columbus area for See Saws, Do-Si-Do's, Cali-Hos, Whirlaways, and several other square dance clubs. The Carters held yearly round dance specials and brought in nationally known round dance leaders such as Eddie and Audrey Palmquist, Jack and Darlene Chaffee, and others. They were members of Roundalab.*

*Marge choreographed sixteen dances – two of the most familiar were songs by Englebert Humperdinck named “The Last Waltz” and “Bicycle Waltz”. They retired from teaching in 1978 and moved to Florida in 1986. About 1988 they got the “bug” to dance again so they danced with leaders in Florida and did a little private teaching for several couples who needed help. Marge and Charlie stopped dancing about 2000.”*

The previous italicized paragraphs part of a document sent to me from a dancer in Ohio. This information is available due to a project spearheaded by Velma Doyle, to highlight a different caller or cuer in each issue of their newsletter. All bios are retained for historical purposes.

Searches by several individuals for her bio have been unsuccessful. She was 97 years old and was living in High Point, Delray Beach, FL 33484, at the time of her passing. There was a service in Delray Beach on December 23<sup>rd</sup>; however, this information was received after the service.

Advance ribbons are available for \$22 per person for 12 hours of dancing and workshops, two halls for dancing (Advanced in one room and Mainstream, Plus, and Rounds in the Main Hall), computer squares in the Advanced Hall, beautiful hardwood floor in the Main Hall, will be held at the Carver Recreation Center in Bartow, and light refreshments. ## *But I Found a Better Rate Online...*

Or I missed the deadline for the room block. Or the room block was full. These are all comments I have heard from dancers who attend square dance festivals and weekends in regards to staying 'in the room block' at the host hotels.

As an organizer of several weekends, I can assure you that juggling the costs of a weekend is challenging. One of the ways that weekend costs are offset is by 'nights consumed' at the host hotel. The nights consumer often times help reduce the price of the dancing spaces and/or caller accommodations. The catch, though is that while you may be staying at the host hotel if you don't stay in the room block, your "nights consumer; won't count toward offsetting the weekend's venue expenses.

At a weekend I recently attended, approximately 15 rooms were booked at the host hotel, but not in the room block. The weekend didn't receive any credit for the approximately 45 'nights consumed' because the rooms weren't booked within the room block.

So what can you do to help?

- Make sure, when calling the host hotel, to book in the room block assigned to the weekend.
- If you are told that the room block is full, check with the weekend organizer to make sure you are receiving accurate information from the hotel.
- Reserve your room early; even if you aren't 100% sure you will attend, as hotel reservations can usually be cancelled without penalty within a few days prior to the weekend.

I know that staying in a hotel, especially for 3 or more nights can be costly, but please consider the part you play in supporting the weekend by helping keep costs and registration fees as low as possible before choosing an alternate hotel or a lesser rate at the host hotel. Supporting your favorite weekends in this way will help keep them active and successful for yours to come.

## *A Look Back*

Thirty – forty years ago, square dancers did fun and crazy things on banner raids/retrievals or mystery trips.

One time, Bay Area Twirlers visited the Gator Promenaders in Lakeland with a 9 x 12 cake pan full of pennies frozen in a block of ice to pay for their dance fees. Not to be outdone, Gator

Promenaders made a banner retrieval trip to BATS with bags of empty aluminum cans to pay our dance fees!

Another time, Buttons & Bows went on a mystery trip. We were on a charter bus<sup>1</sup> on Hwy. 27 going through Haines City when a Haines City Police patrol car came up behind us with flashing lights. We followed the patrol car and taken to the Haines City Police Department. The coordinators of the trip got off the bus and went into the police station. They came back out and told us we had to get off the bus and go into the station. We went to an interrogation room where we had to dance a tip. We each got a jailbird dangle for our efforts!

Then another time, Gator Promenaders was on an overnight Knothead<sup>2</sup> trip. At the hotel, we all had to get in the pool and dance a tip. We received a duck dangle for that one! On the same trip, we went to the Kennedy Space Center, and square danced at the base of the upright shuttle at the front of the space center. At that time, there wasn't a dangle for that.

Buttons & Bows had a mystery trip one time where we had two charter buses full of dancers in full square dance attire. On the way to the restaurant (we thought), we were all given a piece of paper and a pencil and instructed to write down where we were going to eat and where we were going afterwards. Then we had to turn in the papers. One person won a prize for guessing the correct restaurant, and another person won a prize for guessing our final destination. We rode around Lakeland (to throw us off) while we were making our choices and we ended up on I-4 headed to Orlando. We went into downtown Orlando and ended up at Church Street Station<sup>3</sup>. We went to the Cheyenne Saloon, and we had to dance a tip on their dance floor! The

<sup>1</sup> Back in those days, the Buttons & Bows special events were for members only and we always filled two 45-passenger charter buses to go on a trip!

<sup>2</sup> To become a Knothead, a dancer had to go to attend a dance over 100 miles away. At the dance, there was an initiation and then you became a Knothead. This was a "right of passage" for new dancers back then. After a class graduated, the first thing they did was go on a Knothead trip. Being a Knothead entitled the new dancer to attend the annual Knothead Konvention which was always held on Labor Day weekend. Art and Martha Springer ran this Konvention for many years and it was held in Tampa at the old Curtis Hixon Auditorium. They kept track of the attendance each year and could tell you how many years you had been attending. You received a badge that showed how many years you were there. The Springers decided to retire and we didn't have a Konvention for a few years. At the time they retired, one of our member couples had the most years of attendance. They were always called up to the stage to receive their badges. Martha had a list displayed by the registration table that showed everyone's name and how many years they had attended. The list was in chronological order so you could see where you stood. After a few years, Susan Elaine Packer of SuzyQ Creations took over the Knothead Konvention and had a couple of them on the Space Coast but everyone had lost interest and the attendance was good enough to continue.

<sup>3</sup> Church Street Station was an entertainment district in downtown Orlando. All the streets were closed to vehicular traffic and there were numerous shops, restaurants, bars, and street entertainment. When Universal Boardwalk opened, it pulled all the business out of Church Street Station.

bar was open and there were customers there to watch. After that, we went further into Orlando and went to a buffet type restaurant for dinner. After dinner, we ended up at the old Whirl & Twirl Dance Hall. Whirl & Twirl had just put down their new hardwood dance floor and we were the first ones to dance on it. We had a dance that night with Gary Brown calling for us. Several of the Whirl & Twirl members were there to welcome us. During the evening, they served us refreshments and did some skits.

Buttons & Bows used to have a beach weekend each year, but we never went out on the beach! We went on tours, went out to eat, etc.

Another time Buttons & Bows went to the old St. Pete Pier, which had a small enclosed shopping area at the end. We square danced in the center of the shopping area where all the customers could see us. Again, Gary Brown called for us. We used to do demos in the mall on Highway 98 N. They used to have a place in the center of the mall that had a stage and good sized open area around the stage. We would dance on the stage, and people would stand or sit and watch us.

When I was going through some old pictures from Whirl & Twirl, I found this picture. The Space Trackers from the Space Coast, raided Whirl & Twirl dressed as a chain gang!



I also found this picture (below). SusanElaine (SuzieQ Creations) used to have a precision dance team in Orlando. Buttons & Bows members, note the couple at the end of the line doing the courtesy turn. That's Duane and Donna Bouton. They were in our class a few years ago.

The Apopka Pirates also had a dance team.



And look at this picture! The largest class as of February 1979! Even during all the years, I have danced, I've never seen a class this large,
