#### Messages Regarding Suspension of Dances

Several groups have elected to suspend their dances due to the coronavirus pandemic. Below are the messages received. At the end of this section is a list of events that are suspended at this time. If you suspend your event, please notify us. Updates will be emailed as needed and posted at www.dancergram.com.

**From Lake Wales:** Square dancing involves a lot of hand touching. It involves many senior citizens who are defined as "at risk" and are advised to stay home.

Sooner than later, there will be a dancer who has been in contact with infected persons somewhere. If there is an incident of an exposed person being at a dance, all of the dancers and others they are in contact with may need to be quarantined or worse, be infected.

We see other groups taking precautions or limiting crowd gatherings (sporting events, churches, etc.) Should we continue dancing as if nothing is going to happen to square dancers?

**From Keith Stevens regarding Shufflin' Squares:** After some discussion with the leaders of the Shufflin Squares, we have decided to cancel square dances until after the 10th of April. The act is not in fear nor to heighten fears among people; instead, it is to act on the side of more caution than less.

Square dancing involves the population most at risk for complications from the virus, and it affects people who travel regularly and might have exposure to the virus. Further, square dancing involves a lot of hand touching and personal contact between dancers. For all of those reasons and to act on the side of more caution, the leaders have concluded we will suspend square dancing until after the tenth of April, after which we will evaluate the situation.

There will be no dancing Thursday, March 12, March 19, March 26, April 2 and April 9.

Thank you for your understanding.

**From Ron Libby and Keith Stevens regarding Day of Advance on March 21:** As of this morning (3/13/20), we have decided to cancel the March 21 advanced dance at Lake Ashton with Ron Libby and Keith Stevens calling.

After much thought and deliberation, we are canceling the March 21 advanced dance at Lake Ashton. We believe we are acting in the best interests of our dancers and on the side of more caution than less. Refunds will be issued to those who have paid in advance. Thank you for understanding.

**From Charlotte Promenaders in Port Charlotte**: In the interest of the wellness and safety of our dancers, club members and guests alike, we are seriously thinking we should cancel the remaining three dances of our season. Heeding the advice of the health officials around the country and here in Southwest Florida, we think the responsible option to pursue is to cancel the dances until which time that the spreading has subsided considerably. Unfortunately, that will not happen until after April 2, the date of our last dance. We were told that the severity of the virus might well be worse than is being shared with the public.

Taking into consideration the ages and physical issues of our dancers, you know that we are a deeply vulnerable population. Hand holding, handshakes, and hugging are ingrained in our dance interactions, perfect opportunities to share the nasty germs of this virus. Being in any way responsible for any of our dancers becoming ill with this disease would be devastating to us. We are aware that so far, there have not been many diagnosed cases here, but who knows where and when the next cluster will occur?

Just a few minutes ago, we received an email from one of our guest couples saying they would not be coming to any more of our dances this season due, of course, to avoiding the Coronavirus. Certainly understandable, and probably not the only email we will receive saying the same thing. Tim and I have chosen not to attend the dances, which is tough for the presidents to do, but if the club demands we host these dances, the Vice Presidents or a volunteer will have to be in charge.

Inducing panic is not the goal here, but taking a plan of action to protect our dancers is.

**From Ginny Bates:** We need to go one step beyond and cancel all dance events for a month. Our people are too used to handshaking and hugging. Charlotte Promenaders canceled for the season.

**From Pamela and Jeff Johnson regarding March Memories**: After much consideration, and lots of pressure from our children in Minnesota, we have decided to return home early this year. Which means we are canceling our March Memories festival next weekend, and our last Tuesday night class on March 17th. Jeff and I did not make this decision lightly and trust you will understand how difficult it is for us to leave you all before fulfilling your expectations. We will be back next year in November to dance another great season with you all!

Everyone will receive a full refund for the weekend. If you are pre-registered, we have your mailing address and will get your checks off tomorrow.

**Message from Red and Ginny Bates**: we have decided to cancel our square dance season because of the coronavirus. The CDC recommendation was for people 60+ to limit exposure to groups. We are such a hands-on activity that we felt with the season winding down; it's a good time cancel until the fall.

**Message from Marjie Tobey**: Just received word that Riverwoods Plantation is canceling all hall activities, and that means us could you please send an announcement.

The Happy Promenaders Dance, Marjie's special dance this coming Sunday, March 15, has been canceled, the hall is closed.



### 67th (2021) Florida State Square and Round Dance Convention

#### LIGHTHOUSE #1

#### CAPE CANAVERAL AT CAPE CANAVERAL

Since the theme for the next convention is "Lighting the Way for Friendship and Fun in 2021" and their logo is a Lighthouse, I decided to write about the many lighthouses around the State of Florida, there are some 50+ all around the perimeter. I will be starting at Cape Canaveral heading south, around the Keys and back up the other side, and, of course, there are quite a few around the shoreline of the Panhandle. Then jumping across the state from Pensacola Lighthouse to Amelia Island and down to Ponce de Leon Lighthouse ending in Daytona Beach.

In the 1600's Spanish explorer, Ponce de Leon gave the area the name of *Caba de las* 

*Corrientes* (Cape of Currents), which became *Canaveral* but was renamed Cape Kennedy after our President was assassinated in 1963. Some people did not like the change. In 1973 the name of *Cape Canaveral* was restored by an act of the Florida legislature.

The first lighthouse was erected in 1848, 3 years after we became a State but before the Civil War. The first lighthouse was too short and not bright enough, only 60 feet tall. Boats couldn't see the light until they were already wrecked on the Southeast Shoals. In 1850 the lighthouse was shut down because of the warring Seminoles. In 1868 a new lighthouse was built and was 151 feet tall, which made it tall enough for mariners to see the light. This new light stood for 26 years until erosion threatened it, and it was moved to its present site where it remains today.

In July of 1853, Captain Mills Burham was appointed the lighthouse keeper, where he served for 33 years. After his death in 1886, his wife Mary and his oldest daughter were the lighthouse keepers until sometime into the 20<sup>th</sup> century. The U.S. Air Force now owns the lighthouse. It is maintained by the Coast Guard, as all lighthouses are.
