
Thursday now (except the 5th Thursday when we are dark).





"You welcome in strangers And care for each one I surely can see You're all having such fun."


We squared up again As the music it flowed And everyone laughed As we all do-sa-doed.







America has gone to war with quite a few countries and even itself once over the last few hundred years. One of the countries we kept peace with over the years was Canada, though that almost didn't happen.

In 1859 there was a confrontation between the British and the United States over country boundaries in the Pacific northwest. It was then that we almost went to war over a pig. The confrontation was over the San Juan Islands; the dispute began when a Canadian owned pig was shot when eating a potato crop while trespassing on the U.S. side of the boundary. Thus began The Pig War.

Both U.S. and British forces built enforcements and prepared for war. However, both military commanders ordered their forces to stay in a defensive posture not to fire the first shot. After months of stand-off, negotiations proved successful and with the exception of the pig, not a casualty was received nor shot fired.


Parking Availability




