LIGHTHOUSES #38 THRU #41 Cedar Keys Light, St. Marks Lighthouse Dog Island Light, Crooked River Light

#38 Cedar Keys Lighthouse: This Lighthouse is located across the harbor from Cedar Key on Seahorse Key, three (3) miles southwest of Cedar Key and was the site of a watchtower erected in 1801. After the watchtower was destroyed by a Spanish naval force in 1802, it was used as a detention center for Seminole Indians captured in the Second Seminole War (1835-1842), to be held there before being transferred out West. Cedar Key became an important port during the 1840's and in 1850 Congress appropriated funding for a lighthouse on Seahorse Key which was completed and lit in 1854. Federal troops occupied Seahorse Key in 1862 and used it as a prison for the duration of the Civil War. The lighthouse building was tripled in size in 1905 when a U.S. Navy wireless station was established. The light was taken out of commission in 1915. The Cedar Key Lighthouse is the oldest standing lighthouse on the west coast of Florida.

#39 St. Marks Lighthouse: Approximately 25 miles south of Tallahassee is Florida's Big Bend region where the state's Gulf coastline changes from a north-south direction to an east-west

direction. A river empties into the Gulf at this point and it was here that an early settlement was established by the Spanish. In 1818, Andrew Jackson captured St. Marks from the Spanish, however, three years later control of Florida was officially transferred from Spain to the United States. In 1828 a territorial delegate was sent to Congress to petition for construction of a lighthouse at St. Marks. An act appropriating \$6,000 for the construction of the lighthouse was passed. The construction ended up costing \$11,765 but the Collector of Customs refused to accept it since it was built with hollow walls. A replacement tower was accepted in 1830.

Under the 1832 Treaty of Payne's Landing, Florida's Seminole Indians were to relocate west of the Mississippi River by 1835. However, the Indians refused to leave and the Second Seminole Indian War erupted and lasted for 7 years. As the port of St. Marks was growing the land protecting the lighthouse was shrinking. By 1842, erosion was threatening the tower so a new lighthouse was built farther inland, which still stands today. The stout walls are four feet thick at the bottom and taper about 18 inches at the lantern room. A breakwater was built to protect the lighthouse after a hurricane struck in 1843. The tower was used by both sides during the conflict between the States. After the end of the conflict, the tower was repaired and back in service by 1867. In 2016, then Governor Rick Scott was instrumental in getting money allocated for the preservation on St. Marks Lighthouse.

#40 Dog Island Lighthouse: The Dog Island Light was located on the western tip of Dog Island south of Carrabelle, Florida. It marked the "middle entrance to St. George's Sound," between St. George and Dog Island, during the 19th century, until its collapse by a hurricane in 1873. The first lighthouse was a 50-foot brick tower and completed in 1839 but a storm in 1842 destroyed the keepers house and badly damaged the lighthouse tower. A 40-foot wooden tower was completed in 1843 to replace the brick tower however the second tower was destroyed by a hurricane in 1851. A replacement brick tower was completed also in 1851. During the Civil War, Confederate forces burned the stairs in the tower and damaged the lens to prevent the tower from being used as a lighthouse or a watchtower. The light was repaired and put back

into service after the war. In 1872 beach erosion undermined the tower and caused it to fall. The lantern was salvaged and moved to the top of the keepers dwelling. The in 1873 another hurricane destroyed both the tower and the keepers dwelling. Congress appropriated funds for a replacement in 1874 but the local Lighthouse Board recommended that the new work be indefinitely postponed. The Dog Island Light was never replaced. However, the Crooked River Light (built near Carrabelle on the mainland in 1895) serves as a leading light for the same channel that was formerly marked by the Dog Island Light.

#41 Crooked River Lighthouse: This lighthouse was originally constructed in 1895 to replace a nearby lighthouse on Dog Island that was destroyed in a coastal hurricane in 1873. After many years of flawless service this lighthouse was officially decommissioned in 1995 and sat isolated and almost forgotten for several years but in 1999 a group of local residents created the "Carrabelle Lighthouse Association" and obtained ownership of the landmark. Private and public funds helped commission the restoration that was completed in 2007. The new skeletal tower lighthouse stand 103 feet tall and is the tallest lighthouse along the Florida Panhandle.

LIGHTHOUSES #42 THRU #45 Cape St. George Light, Cape San Blas Light St. Joseph Point Light, St. Joseph Bay Light

#42 Cape St. George Lighthouse: This brick Lighthouse stood for 153 years until it toppled into the Gulf of Mexico in 2005. Over the years it had to be erected three (3) times.

First in 1833: It was erected near the island's western tip where it marked the narrow entrance to Apalachicola Bay, it stood 65 feet high. However, because of the sharp bend in the coastline ships could not easily seen the if they were approaching from the eastern Gulf so appropriation money was issued to move and rebuild the lighthouse.

Second in 1848: Materials from the old tower were used for the new tower. Although the foundation was of brick, a hurricane in 1850 weakened it and during the fourth hurricane of the 1851 Atlantic Hurricane Season it toppled in August of that year.

Third in 1852: It was rebuilt 250 yards more inland, often using salvaged bricks from the original light. This light was under Confederate control during the Civil War.

In 1995 Hurricane Opal was so sever it caused the light to lean 10 degrees. The tower was righted in 2002 but then it completely collapsed in October 2005. Island Volunteers saw to it to be rebuilt in the middle of St. George Island and it is now open to the public.

#43 Cape San Blas Lighthouse: This is another situation where four (4) lighthouses have been built over the course of several years.

First in 1848: The Lighthouse was built on shoals running out from the Cape for 4.5 miles which made it dangerous for all vessels nearing the coast as the light was not that tall and could not be seen well enough. The lighthouse collapsed during a gale in the autumn of 1851.

Second in 1856: Unfortunately this light had been completed only a few months when it was destroyed by yet another sever storm, also in 1856.

Third in 1858: This lighthouse sustained serious damage but not by storms but by Union troops that landed in 1862 during the Civil War. Repairs were made and the light was re-established in 1865. Beach erosion was of great concern for the stability of the lighthouse but no appropriations were made and soon storms again destroyed the lighthouse.

Fourth in 1885: This tower was a skeleton tower of iron with a light said to "light up the entire horizon". However, by 1887 the beach had started to take its toll but Congress decided the present site cannot be saved and wanted the lighthouse moved inland so it was rebuilt on near by Black's Island in the early 1900's. It is still in operation.

#44 St. Joseph Point Lighthouse and

#46 St. Joseph Bay Lighthouse: These two (2) lighthouses pretty much co-existed in the 1830's. The town of St. Joseph was founded in 1836. Also in 1836 the Legislative Council of the Territory of Florida petitioned Congress for a lighthouse to mark the entrance to St. Joseph Bay, it was approved but was built on St. Joseph Point becoming operational in 1839. It was a white conical brick tower 55 foot tall. The town of St. Joseph boomed and in 1838 hosted its Constitution Convention to lay the ground work for Florida to become a State. However, in 1841 a ship brought yellow fever into the community. Within a matter of weeks, the town of St. Joseph was almost deserted. Two years later a hurricane with a huge tidal wave managed to destroy the city. The city did not survive to see Florida become the 27th State in 1845. The lighthouse did remain in service until 1847 when the light was extinguished and relite at Cape San Blas. For over 50 years, St. Joseph was known as the "City of the Dead", but people started to return to the area around the turn of the 19th century. Eventually the City of Port St. Joe was established just a few miles from the original site of St. Joseph.

In 1955 the old dwelling was sold to a private citizen who made it into a hay farm for cattle. Again, the home was sold to its present owners who moved it about 20 miles to its new home site on St. Joseph Bay. It is a private residence now, no visitors permitted, and is referred to as the "traveling lighthouse".

LIGHTHOUSE #46 Pensacola Lighthouse "HAUNTED"

#46 Pensacola Lighthouse: The first Pensacola Lighthouse was not a house at all but a "Lightship" called the "Aurora Borealis" which had been moved from its post at the mouth of the Mississippi River to Pensacola in 1823. It was not until 1825 that a 40-foot

tower was built at the south entrance to Pensacola Bay which was a bad idea as it was obscured by trees so in 1858 a new 150-foot tower was constructed on a 40-foot bluff on the then Pensacola Naval Station, it was painted all white. Sometime before 1860 the light in the tower went dark for reasons unknown.

Going back in history, at the start of the Civil War (1861), Pensacola was controlled by Confederate forces while across the bay Fort Pickens was controlled by the Union forces. Later the Confederate forces evacuated Pensacola and Union forces took over. In 1863 the Pensacola Lighthouse was relit and the upper 2/3rds was painted black and it remains so to this day, black on top and the lower white.

The "HAUNTING"

The "Haunting" centers around an early keeper of the Pensacola Light named Jeremiah Ingraham. He took his maintenance duties very seriously climbing the 177 stairs nightly toting a bucket of whale oil in each hand to fill the early lamps to keep them lite for the night. After 14 years of this grueling work he died but not from a broken back or heart attack but----- murder ----- which is still a mystery to this day.

As most mysteries start - it was a dark and stormy night both outside and inside the lighthouse. Outside hurricane force winds howled while inside a violent verbal exchange was going on between the keeper and possibly his wife, (not known for sure if it was his wife or jealous lover). Each screaming and cursing as violent as the storm outside. After about an hour the brawling stopped amid a lot of pain like screams. "No-No" the keeper shouted, then complete silence! A short time later the lady dashed outside running in circles and sobbing uncontrollable, covered She was holding an ivory handled long bladed fisherman's knife. Authorities found the keepers lifeless body in the upstairs bedroom, his blood collecting in a huge pool on the pinewood floor near the fireplace. After a complete investigation of the murder scene, a crew was sent in to do the nasty job of cleaning up the crime scene including the bloody mess by the fireplace but the next day the stain stilled showed. It was cleaned up again but the following morning it had returned, as it did day after day after day, and the smell also continued. Finally, the bedroom was closed off completely.

The woman pleaded self-defense even though the town officials were suspicious of her motives not to mention the violence of her act, they released her to return to the keepers' dwellings. It is said at dawn the next morning she was performing the keepers' duties of climbing the 171 stairs and filling the lamps with oil. The woman's identity, unfortunately, has been lost to history.

Construction workers renovating the lighthouse after the tragic incidence reported hearing laughter, moaning, breathing and footsteps on the iron stairway. Some say they even saw a ghostly figure at the window of the locked door. Many other unusual sightings and noises have been reported over the past 125+ years since the murder. Weird horrid laughter from closed rooms. Happy laughter echoing in the hallways. Footsteps being heard on the metal steps with no one there. All doors locked at night only to be standing wide open the next morning and the instances go on and on. For the most part the lighthouse in cordoned off to the public but some tours are available.

The stain on the bedroom floor has been proven time and time again to be <u>blood</u>. It stubbornly refuses to budge no matter how hard it is scrubbed and with every know cleaner. It has even been sanded.

LIGHTHOUSES #47 & #48
Fort Barrancas Range Lighthouse &
Fort McRee Range Lighthouse

#47 Fort Barrancas Range Lighthouse: Fort Barrancas was built on the site where numerous previous forts were constructed



by the Spanish in 1698. It was taken over in 1707 by Indians under the general leadership of some English traders. In 1719 French forces captured Pensacola and destroyed this Spanish Fort. Following Britain's defeat of the French in the Seven Years War, in 1763, it exchanged some territory with Spain and used this site as a harbor fortification, building the Royal Navy Redoubt there in 1763. More than a decade later, the Spanish joined the war against them during the American Revolutionary War. After the war the Spanish retook control of West Florida.

During the War of 1812, between the United States and United Kingdom, the fort was the scene of the American victory at the Battle of Pensacola with the help of some Indian allies and some allies of the British, Spanish and Creeks. In 1818 the Spanish part of the garrison exchanged cannon fire for a few days which eventually lead to the Spanish surrendering the fort to American hands.

When the United States purchased Florida from Spain in 1821, it selected Pensacola as the site for a major Navy Yard. Fort Barrancas was reconstructed and expanded from 1839-1844 and it

was strengthened to defend both ships entering the harbor and from attacks across land. In 1861, before the start of the Civil War, a company of U.S. Army soldiers fired upon the militia of Florida state troops demanding them to surrender the fort but to no avail as the Union held the fort throughout the Civil War.

In October 1861, a small Confederate force of troops landed east of Fort Pickens but was repelled by Union forces. Fort McRee and Fort Barrancas exchanged heavy cannon fire with Fort Pickens in November 1861 and early 1862, however, in May of 1862, after learning that the Union Army had taken New Orleans, Confederate troops abandoned Pensacola.

Stronger rifled cannons and ironclad ships developed during the Civil War made Fort Barrancas outmoded so it was converted into a storage area and small arms range in 1946. In 1947 the fort was deactivated and it was incorporated by the U.S. Navy into the Naval Air Station of Pensacola.

#48 Fort McRee Lighthouse: Fort McRee was not officially given its name until 1840. It was named for a Colonel William McRee, an Army Engineer.

However, going back in history, following the war of 1812 this fort was one of 3 major installations built by the United States to strengthen its defenses at Pensacola Bay. It took from 1834 to 1839 to build because of its placement on a "boomerang" shaped barrier island. It had 19 casemates (4 on each face, 1 on the top and 5 on each wing) which, hopefully, was enough to stop enemy ships. Although the fort itself was completed in 1831, its 122 guns (cannons) were not installed until sometime between 1843 and 1845 even though the first troops started to arrive in May of 1842.

After the Mexican-American War ended in 1848, more barracks needed to be built for more troops but these were built near Fort Barrancas. At the time Fort McRee was used mainly for war dills, practicing maneuvers and target practice. Two other Pensacola area forts were manned the same way until the outbreak of the Civil War.

In early January 1861, the Union soldiers at Fort Barrancas fired

upon the Florida Militia, firing the first shots of the war. For two days, a garrison spiked the guns at Fort Barrancas and Fort McRee, then moved across the bay to Fort Pickens. This move was a timely one as by mid-January, the Florida and Alabama militia took control of the deserted fortification. Over the next several months both sides built new cannon batteries and brought in more personnel. Opposing forces engaged in cannon duels but with little effect. Few men remained on the Confederate side and even fewer Union soldiers on Fort Pickens side.

In October 1861, a Confederate commander ordered an assault on Fort Pickens which was unsuccessful. The Union side planned an attack of its own. Fort McRee was the closest fortification to Fort Pickens, the primary assault to be Pensacola. On a morning in mid-November 1861, Fort McRee was attacked by Union forces at Fort Pickens that initially returned such strong fire the Confederates were unable to hold their own even though there was such heavy damage that the guns at Fort McRee fell silent that evening. Again, early AM in mid-November a ship resumed its attack on Fort McRee but the guns at Fort McRee remained silent signaling the end of the skirmish. Fort McRee survived but was badly damaged. When the Confederate forces abandoned Pensacola in May of 1862, they burned Fort McRee and several other buildings believing they were of no strategic value. Battered and burned was how Fort McRee remained for the next 3 decades. Renewed interest in 1899 to strengthen the Coastal defenses of the US, activity began at Fort McRee when a battery of rapid fire guns was installed.

A hurricane struck in 1906. Of the three forts that once protected Pensacola, Fort Pickens and Fort Barrancas were preserved first by continued use and later used as historic sites. But Fort McRee was left to the elements where storms and erosion have taken their toll.

Getting to and around Evansville

Getting to Evansville for the 71st National Square Dance Convention® is as easy as putting in your rowboat and paddling the Ohio River until you see the Evansville courthouse tower peeking out from the town's skyline.

If you don't want to take the transportation our River Rats did, there are plenty of other options. Two interstates, I-64 going east-west and I-69 going north-south, run through the city, as well as U.S. 41, another north-south road. I-64 passes through Louisville and St. Louis as well.

For those looking for aerial transport, four airlines, Allegiant, American, Delta, and United, fly into Evansville Regional Airport, though you will probably have to take a connecting flight.

Once you're in the city, there are a few transport options, even if you don't have a car. Several major car rental services are available at the airport. The city also has the Metropolitan Evansville Transit Service (METS), with 22 fixed routes, and operates from 6 a.m. to midnight. Lyft and Uber also operate throughout the city.



Licensing Can Affect
Your Club
By Jerry Reed
Many callers, dancers, and club officers are still expressing concerns about the



Broadcast Music, Incorporated (I), The American Society of Composers, Authors and Publishers (ASCAP), and CALLERLAB1. This Press Release is intended to address many of these concerns and lead to a better understanding of the licensing agreements.

agreements

Point One: It's illegal to play copyrighted music in public without the author's permission, which is a "license". It would be impossible for each author to license songs individually, so BMI & ASCAP were formed to manage the licensing. Anyone who performs or plays copyrighted music needs a license. Normally, the event's organizer is responsible for obtaining the required licenses. For commercial concerns, that's usually the promoter. For commercial trade shows, it's the trade-show organizer or individual booth-holder. For square dances, it's the dance sponsor. Most dances are club-organized, so the clubs are responsible for being licensed.

Point Two: Over the past 50 years, BMI and ASCAP have turned their sights to square dancing several times; however, there was never an easy way for them to track down square dance clubs for licensing and enforcement. At one point they discovered square dance publications, which made it easy to find clubs. They mailed out about 7,000 contracts to individual clubs and callers. This made people realize their exposure and caused much concern. BMI & ASCAP offered their standard deal: \$22 per dance, payable on an annual dance, in advance. For many clubs, that would have been devastating. It would have been impractical and nearly impossible for clubs to negotiate for better terms. In addition, many new clubs would face an impossible up-front expense.

Point Three: As an alternative, CALLERLAB2 & ROUNDALAB approached BMI & ASCAP on behalf of square dancing and round dancing and arranged to offer licenses to their members. This was

very appealing to both BMI and ASCAP because they would only need to deal with one customer for square dancing and one customer for round dancing. This arrangement was also good for activity because of the negotiations undertaken CALLERLAB and ROUNDALAB. Therefore, the result was a much better price for music performance licensing. This arrangement was also meant the clubs would be protected by the caller's and user's license. As part of the negotiations, BMI & ASCAP insisted that the U.S. Members be licensed. Please remember, this licensing problem was not initiated CALLERLAB or ROUNDALAB. BMI and ASCAP were service organizations similar to CALLERLAB or ROUNDALAB. They provide a service to their members. Their purpose is to collect royalties on copyrighted music for their members. They are supported by Federal law in their efforts to collect these royalties.

Point Four: To help protect your club, CALLERLAB recommends that clubs add the following to contracts or agreements with callers: "I CERTIFY THAT I WILL BE LICENSED BY BMI AND ASCAP TO PERFORM COPYRIGHTED MUSIC AT YOUR CLUB DANCE."

Point Five: If a club has a signed contract without this statement, CALLERLAB recommends that the club contact the caller as soon as possible to verify that they will be licensed by the time they call a dance. If the caller indicates that he/she will not be licensed, the club must take steps to cover the dance. Clubs may contact CALLERLAB to determine if the caller is a CALLERLAB Member and is licensed.

Point Six: If BMI or ASCAP representatives visit a square dance, they will determine if the club, caller, or cuer are licensed. The penalties can be as high as \$20,000 per copyrighted song performed and/or up to 10 years in federal prison for each violation, Since the club officers are typically considered to be the sponsors of a dance, they might be the ones usually names in the lawsuit, legally, however, the caller and/or cuer could also be named in the lawsuit.

Point Seven: Clubs are protected by hiring only callers who are licensed. Clubs need to know that all CALLERLAB Members in

the U.S.A. are licensed to perform BMI and ASCA music.

EDITORS'S NOTE: There is also an agreement with the American Callers Association (ACA)

You Can't Have It Both Ways

- 1) You can find new dancers that are willing to become dedicated square dancers.
- 2) Or you can find new dancers that want to have fun and don't want to spend a lot of time learning how.

Most of the population in the U.S. fits into category #2. When we entice people to start square dance lessons, they usually have no idea how much information they will have to learn before they will be competent to dance with the average Modern Western Square Dance club, If they knew, the majority would tell you they don't want to do that.

The average person today memorizes very little. If they want to know how a word is spelled, they are aided by the word processor. If they want to recall an appointment, it's on the calendar on their cell phone. They don't have to remember hardly anything. Just where to look it up.

In the present form of modern western square dancing, the dancer has to memorize up to 100 commands from several positions The average person considering lessons is not told this. If they were told they would probably say no way.

The definition of square dance "basics" is understood differently by dancers and callers. If you ask any square dancer how to do any "basic" they might be able to describe a couple of variations, but they will not be able to describe all the variations most callers know. The art of doing the variations depends on doing each variation enough times that the action becomes "bodymemory." That takes years of practice dancing to callers who actually use these variations.

Learning any dance form, other than square dancing, is a matter of

practicing routines usually composed of several moves hooked together (Modules). Remembering each move in the sequence is not a matter of breaking the sequence into individual parts (basics) for most dancers it's a matter of doing the whole sequence until they can dance the sequence in their sleep.

A lot of the problems with MWSDing is that MWSD callers think they have to always keep-the-dancers-on-their-toes. Modern callers don't call what they think the dancers know how to do. They try and call sequences they think the dancers are unlikely to know.

To do that, the dancers have to understand the definitions of each "basic" well enough to make decisions that may or may not be right. Very few dancers can do that without years of practice. How can dancers just out of lessons be expected to do that?

In all other dance forms, the teacher shows the dancers the correct way to do a sequence before the dancers are expected to dance the sequence. The dancers are shown, not told. This is where we have a big disconnect between what the large majority of dancers can do and what callers prefer to call.

All modern western square dancing is presently a process of culling out a lot of dancers to select the few dancers that can learn the things they will need to learn or not square dance. We have no middle ground where the dancers, that are not fast learners, can gain experience. This is the majority of any dancers that graduate from any present square dance class.

Because if all the above, the average square dance class losses 80% of the people who start lessons. After the square dancers graduate, 80% of the remaining dancers will dance for less than one year. They get discouraged with the commitment modern western square dancing requires and they have no place to go.

You have to choose whether to have a few dancers educated and competent in performing 100 square dance "basics" or you can have a lot of dancers who know fewer "basics" and the caller calls easier dance routines.

The attrition rate for square dancers is a disaster and has been a disaster for 40 years. The average incoming student at lessons hits

a wall about the time they have been exposed to about 30 "basics." At this point, they need to consolidate what they have been taught and just dance for quite a while. For some new dancers, it is a wall they can't penetrate at all. For some new dancers, the process is just a matter of a lot of practice.

Many of these dancers would be happy just dancing what they already know. If they are pushed any further, they will quit dancing or become the bumblers we see on a lot of square dance floors today. Only a few dancers will be able to adsorb more "basics".

At the end of the lessons, new dancers would really benefit if they only danced routines they have danced. A lot of them would be happy to end their education at that point. These are the dancers that are likely will drop out the first year.

The few, the proud, who survive will be ready to tackle more "basics" and climb on the square dance escalator. That is not going to be enough people to support Plus clubs and beyond. You can't have it both ways. Either change how we are teaching new dancers or square dancing will continue to decrease in size until it dies a sad and painful death.

LOST SQUARES PROCEDURE

(REV A - Approved November 19, 2004)

In 1986 CALLERLAB introduced a procedure for SQUARES'. approved Ιt was with some small changes in 1987 and has now been revised. CALLERLAB recommends that dancers use the following and Singing Call Procedures to help lost squares quickly resume Callers should teach procedures to their dancers and be alert for sets waiting to re-enter struggling the action and for sets singing calls.

PATTER PROCEDURE - Make Normal Lines, Wait for Entry, during Promenade a n d Sort The following procedure is intended for use during Patter or calling when longer sequences Hoedown likely and at least half the square is confused. If only one or two then they should lost are a helpful hand and attempt to fill the vacant spots within the still functioning square.

DANCER'S RESPONSIBILITY

- 1. If dancers in a confused but partially functioning square hear "Make Normal Lines", then lost dancers should quickly adjust to Normal Couples (Boy left, Girl right) ready to join the forming Normal (Boy-Girl-Boy-Girl) Facing Lines.
- 2. In the case of total breakdown each dancer should return to possible. home position as soon as Then head ladies join hands with their corner and the head couples back lines out to form normal at the sides the square.
- 3. On the caller's command, "Normal Lines, Go Forward and Back", all lost squares enter into the dance pattern. If a resolution is heard first, then dancers in lost squares should simply readjust to a squared set.
- 4. Dancers in a lost square must remember that re-entering from normal lines does not guarantee a

correct resolution. Full recovery will probably require rapid sorting to home during the Promenade (move counter-clockwise but step out at your home).

CALLER'S RESPONSIBILITY

- 1. Recognize that a number of sets have broken down and have formed lines.
- 2. Place the dancing squares into facing lines that are in a normal BGBG arrangement (#0L).
- 3. Give the command "NORMAL LINES, Go Forward and Back" in a bold voice, which is the command for the lost squares to enter into the dance pattern.
- 4. Allow enough time during the Promenade for squares that were lost to complete their Promenade and sort as necessary to get home. If an "at home" resolution is used, make sure all the sets are squared up.

SINGING CALL PROCEDURE - Swing, and Men Sort during Promenade

The following procedure is intended for use during a Singing Call t h e sequences where a r e short a n d closely timed to the music. The minimum needed to avoid more resume dancing confusion and a t the next sequence is each man at home with some lady for a partner.

DANCER'S RESPONSIBILITY

Since partners probably should be changing, dancers in a lost should ready for quick square be a with their corner or nearest opposite sex and then expect to make adjustments during t h e Promenade that the men end at home. If still lost during the Promenade, men quickly head for home should ladies should join the closest un-partnered man.

CALLER'S RESPONSIBILITY

In the case of significant breakdown on the floor, adjust the choreography or provide more clues and cues to improve the success rate on the next figure.





She was born December 14, 1935 in Port Huron to the late Henry and




Stella Shaffer. She married Fred Eveningred on July 11, 1964 in First Presbyterian Church of Port Huron.




Maureen Taylor passed away unexpectedly several months after losing her husband, Dick, who passed in June 2020.

- 10. The President of CFA will present the award at the annual President's Ball.
- 11. The name(s) of each new award recipient will remain unannounced until the presentation is made.
- 12. Nominations should be in the form of an essay and typewritten, if possible, and must be signed by the person making the nomination.

CFA is an organization that works for the betterment of the entire square dance community.

Those dancers who have a desire to see the activity continue should have a say in the business of what we do.

(e.g. "Ask not what the CFA and square dancing can do for you, but what you can do for the activity.")

Clubs should not be working alone, when we can work together as an organization.
