#### MINUTES OF THE FLORIDA FEDERATION OF SQUARE & ROUND DANCERS MAY 27, 2001 LAKELAND, FLORIDA

The meeting was called to order at 9:00 a.m. by President Dee Dee Stovall. Guests were introduced: From the Northeast, Bud & Edith Taylor; from the West Coast, Joyce & Emory Johnson and Delores & Alvin Mahon; from the Northwest, Ron & Cupie Knowlton.

We had a moment of silent prayer in memory of Frank Trott from the Southeast Association.

The president addressed the issue of a green card caller in the Northeast Association who is a delegate to the Federation. He stated that he will look into the matter.

The president presented a plaque and a dozen roses to Frank & Nan Habersberger who are moving to Colorado. They were recognized for their many years of service to the Federation and to the square dance activity in Florida. A plaque was also presented to Chet Vetter who has submitted his resignation to the Federation. Chet has been a great supporter of the Florida Federation of Square Dancers. His activities for the organization are too numerous to mention, the latest of which is as manager of the Square Dance Hall of Fame at Strawberry Squares. Both Chet and the Habersbergers will be missed in the state.

If you have not been doing so, the President suggested that you read the editorials by Bill Boyd in the Bow and Swing. Bill has some good ideas for us and writes an inspirational article.

Worley Carrier reported that as of the end of April over 11,000 people were registered for the National Square Dance Convention in Anaheim next month. Worley would like to see a large Florida delegation there.

HALL OF FAME: A standing ovation was given to the Herberts and Taylors on their award. Mary added her appreciation to Chet Vetter by reading a write-up for Chet & Julia Vetter from May, 1987.

#### CHET & JULIA VETTER

The Vetters have been "trouble shooters" for the square dance movement in Florida for many years. In 1966 they were on a committee to help keep Bow & Swing going. A few years later Chet was appointed by the Federation to help solve some problems in the West Coast Association. It was solved and they are still using his plan. In 1972 he was

instrumental in healing a rift between some dancers and callers by establishing a Coordinating committee and thus helped to keep the State Convention intact. He also developed a program to smoothly bring the Northwest Square and Round Dance Association into the Federation activities.

Among Vetter's other credits are: serving as President of the Northeast Association; Chairman of the Federation; Delegate to LEGACY, serving on the Board of Directors and programming their panels at the National Convention from 1982 through 1987; taking the first Florida Showcase to Louisville in 1970 to promote Florida dancing; served as moderator and panelist in many of the 17 Nationals they attended and wrote numerous articles and a couple of chapters of the LEGACY Leadership Manual; co-creator of the Florida Square & Round Dance HALL of FAME and co-originator of the "Circle of Service"

Chet & Julia are hard-working square dancers who give freely of themselves without thought of reward. Chet's philosophy is "I'm only giving back a small part of what I have received from square dancing".

LEGACY: No report.

HISTORIAN REPORT: Jack thanked the delegates for cards, prayers and good thoughts during his surgery. It worked!! He is here!! See separate file "Committee Reports".

ASCAP REPORT: See separate file, "Committee Reports".

U.S.D.A. INSURANCE REPORT: Report is in separate file "Committee Reports." TREASURER'S REPORT: Since the treasurer was heading up the 2002 Convention Kick-Off practice, his report was delayed until this time. Report is included in "Association Reports" file.

GUEST SPEAKER: Tom Perry spoke to the Federation about the Florida Dance Web. We've had a bad year in the state this year with people passing away, having heart attacks and such. We have a newsletter on the web site called **fdwflash**. If you want to sign up for it just click on it, it sends me an e-mail that says "put me on the list." So that if anyone in your area has a problem, I put it in the newsletter and it goes out to you. I've had a lot of good comments on this feature at this convention, so I know it is of value to dancers.

The Florida Dance Web now has a sister site called **squaredancing.org** for new dancers. The idea is to get the word out, and to provide a place for those dancers who are in class or have just finished class to go to get help in different things. The first page concerns what square dancing is about, there is a page about CALLERLAB, and a page about ethics and a page with links where you can obtain videos, and just about anything you might need to know if you are a new dancer. Check it out, there are some important pages.

In order to guide people to that page, we have made available through that domain free e-mails to anyone who wants one. Here is what happens: every time you send an e-mail out, there is a little message at the bottom that states "learn about square dancing at squaredancing.org" and that is a link. Whoever clicks on that it will take them to this web site and they then will be exposed to all that information. We welcome you to check this out.

COORDINATING COMMITTEE REPORT: Murl expressed his and Sally's appreciation for the award they received last night. He also stated that the West Coast is very devious in keeping this a secret. Murl also thanked the delegates for the many cards, e-mails, and prayers he received during his illness. They really helped. See his report in a separate file, "Committee Reports."

OLD BUSINESS: Document Changes. In Murl's absence in February, the Federation delegates approved the revised Federation documents with the knowledge that Murl would be coming in with some recommendations for clarification. He presented those recommended changes as follows.

#### Articles of Incorporation:

1. Article V., 6th paragraph "Each person appointed as Federation delegate will have one vote. (clarified as one vote for husband and one vote for wife. A single would have one vote). Permanent delegates would have one vote per couple or 1/2 vote per person.

remove the ( ) wording, change the last sentence to read "Permanent delegates would have 1/2 vote per person."

The revised Articles of Inc. need to be filed with the Dept. of State. There may be a special fom for this. Fee will be charged. The last published fee was \$35.00.

#### By-Laws:

In the following places we have used the term "voting delegates". The word voting can be removed as it has no meaning.

Article IV, Sec. 1, remove the word "voting"

Will now read "they will serve as the regular delegates"

Article IV, Sec. 2, 2nd line, "voting delegates", remove the word voting.

will now read "All Past Presidents of the Florida Federation of Square Dancers shall become permanent delegates, etc."

Article V, Voting, change Sec. 1, 2, and 3, to clarify and simplify without any change in meaning.

Section 1, Regular delegates will have one vote per person.

Section 2, Permanent delegates will have 1/2 vote per person.

Section 3, remove and change last two sentences. now reads--They will have two votes (clarified as one vote for each person). A single delegate would have one vote.

change to read--They will have one vote per person.

Murl made a motion we accept the changes to the Articles of Incorporation. Don Slocum seconded. Motion passed.

Fred Chatos seconded Murl's motion that changes to the By-laws be accepted. Motion passed.

Changes to the Constitution. Since we cannot approve changes to the Constitution without a 30 day notice, we will vote on this change in November.

#### Constitution:

Article X, Section 1, Dissolution—re-word to be more consistent with the Articles of Inc. and to simplify.

- a. To any recognized not-for-profit organization in any proportion deemed advisable.
- b. In no event shall the assets be distributed to any officer, delegate, or employee of the Corporation.

Original (a), removed, (b), the word charitable was removed and changed to (a), (c)is now (b), no change.

The President stated, "You have been notified today and these changes to the constitution will be voted on at the next meeting."

#### RECOMMENDATIONS

- 1. All documents be stored on a floppy disc or CD and kept with the records of the Corporation with the Secretary.
- 2. All future suggested changes to the documents be submitted to a committee to review for correctness and compatibility before they come before the Board of Delegates. This committee could be added to the list of Standing Committees.

  This would:
- 1. Avoid some of the misplacement of items in the documents.
- 2. Correct and simplify wording to be consistent with the balance of the documents.
- 3. Review suggested changes as they may conflict with non-profit corporation statutes or other parts of the documents.

Murl made a motion that his recommendations be accepted. Item 2 of his recommendations would be added to the Standing Rules as Section XIV as an additional Standing Committee known as the Document Review Committee. Don Slocum seconded the motion. Motion passed.

Murl also received some suggested changes to the By-Laws from Frank Habersberger. He reviewed Frank's suggested changes and offered his comments which follow. It is up to the delegates to review and decide how they want to handle these changes.

#### FRANK HABERSBERGER'S RECOMMENDED CHANGES TO BY-LAWS

Changes to ArticleVI, Election (current wording-regular type, Frank's suggested changes-**Bold type**, Murl's comments-CAPS)

Article VI, Section 1, The Board of Delegates shall choose from among themselves a governing body of officers, that shall be known as the Executive Board. delete this section. THIS SECTION SIMPLY MEANS THE EXECUTIVE BOARD WILL BE SELECTED FROM THE DELEGATES. NOT SURE HOW THIS WILL IMPACT THE FEDERATION IF DELETED. ALSO IF DELETED THE ARTICLES OF INC. MUST BE CHANGED AS THIS IS FILED WITH THE STATE AND HAS THE SAME WORDING, ARTICLE 5, SEC. 3.

(proposed Article VI, Sec. 1, The President shall appoint a Nominating Committee prior to the Annual Meeting. The Comittee shall present a slate of Officers at the Annual Meeting. The Nominee for Parliamentarian (presented by the Nominating Committee) must be approved by the Executive Board of the Nominee's respective Association, and such approval must be in writing. THE ABOVE IS THE SAME AS THE CURRENT ARTICLE VI, SEC. 2., THE FOLLOWING IS NEW

In the event that the designated Association submits two Candidates, it must provide the Chairman of the Nominating Committee with the names, Resume's and any additional

evidence of Service to their Association and to the Federation Based on its review of the resume's of each Candidate, the Nominating Committee shall select the one it has deemed best qualified for the position of Parliamentarian. THIS PUTS INTO WRITING A PROCEDURE FOR THE NOMINATING COMMITTEE WHEN MORE THAN ONE CANDIDATE IS BEING CONSIDERED.

#### proposed Article VI, Sec. 2 (previously Sec. 3)

At the Annual Meeting each year, the first item of Old Business shall be the Report of the Nominating Committee, which shall list the Nominees from each of the five Member Associations for the positions of: President, Vice President, Secretary, Treasurer and Parliamentarian. THIS PROPOSAL REMOVES "AND AFTER WHICH THERE WILL BE A CALL FOR NOMINATION FROM THE FLOOR FOR EACH OFFICE," ETC., THIS CHANGE WOULD APPEAR TO REMOVE THE ELECTION PROCESS AND MAKE THE POSITIONS APPOINTIVE.

#### proposed Sec. 4 becomes Sec. 3

Section 3, The President will cause an election to be held for each office and the candidate receiving the majority of votes for the office will be elected.

AS THE NOMINATIONS FROM THE FLOOR HAVE BEEN REMOVED ABOVE THERE IN EFFECT WOULD BE NO ELECTION. WE COULD REMOVE OR REWORD THIS SECTION TO GO DIRECTLY TO THE INSTALLATION OF NEW OFFICERS, WHICH IS THE OLD SECTION 5.

Frank asked that when we do vote on changes that the Constitutional voting process be used. That is, a vote be taken of the delegates who have one vote per person. A separate vote should be taken of the permanent delegates who have 1/2 vote per person.

Joe Vaccari spoke to the delegation concerning the basic right of this organization to elect its officers. So, if we are going to do it by association, we are taking away the right of a delegate from another association to determine who will be the officers. If an association puts someone up for office and you choose, as a group, not to have that person, you have a right not to let them get on the board.

The president asked that we hold all discussion on the changes until the delegates get a copy of the proposal and reads and studies the recommendations so everyone will fully understand.

Don Slocum addressed the fact that Robert's Rules of Order states a president who starts a meeting should finish a meeting. President should not step down in the middle of a meeting.

Pee Wee Stewart spoke on the Northeast delegate situation. He stated that a green badge caller being a delegate is in violation of our constitution or by-laws. Murl stated that we should address what a caller or cuer is and put it in our documents.

Donna Hendricks took the mike and asked who and what are we discussing? The president explained that the delegate in question is Jack Herpy who is not a caller, but rather is in training. He does singing calls at charity events. He receives no money. The Caller's Association does not recognize him as a caller.

Fred Chatos stated that if associations check closely and be clear on their delegates before selecting them there should be no problems.

Carole McKinzie thanked Ken & Sue Brown #2 for putting up the Federation showcase. She and Garland were delayed getting to the Convention and asked for assistance from the Browns. All the Showcases look terrific.

NEW BUSINESS: The president announced appointment of the nominating committee: Chairman Howard & Jettie Crowe, from the Central Association Dewey & Donna Hendricks, and from the Southeast Association Fred & Carolyn Chatos.

The president stated he will form a committee to address changes to documents concerning definition of a caller.

Don Slocum made a motion to adjourn. Seconded by Fred Chatos. Meeting adjourned at 12:00 noon.

I realize that when Ray Huddleston said it was his last report to the Federation that it is also our last one, since it is only about half way through our year. Patti and I were talking about our year and said that, really, your first year is just a learning curve; everything is new and perhaps we may want to come back later and make use of the knowledge, but this year we are just still learning about it. I feel it would be extremely useful if we had a "president's forum" or something like that to find out what other associations do about various issues.

It was decided to form a small committee to look into these two issues. Joe Vaccari agreed to chair the committee to consider these items for the general revision of our by-laws and standing rules. The first meeting was held and we did resolve the issue of "freebies". I would be most interested to find out how other associations handle "freebies" at their dances. Basically we

are going to recommend that we eliminate freebies at our dances with one exception. The Couple of the Year will get free admission at our dances during their year. Insurance has not been resolved completely.

The meeting was followed by a dance, but it was not well attended for the same reason the meeting was not well attended: it was in Tallahassee. We will have our next dance on July 28. Attraction is that we have a band for the square dance. We hope we will see you there.

We had a big dance at Panama City this month which was well attended.

Fred & Shirley have really got the State Convention for next year well along and I'm sure you will all enjoy it, as well as the kick-off this evening. We got up at 7:00 this morning to rehearse it, so you had very well better enjoy it.

By-Laws

In the following places we have used the term "voting delegates". The word voting can be removed as it has no meaning.

Article IV, Sec. 1, remove the word "voting"

Will now read "they will serve as the regular delegates"

Article IV, Sec. 2, 2nd line, "voting delegates", remove the word voting.

will now read "All Past Presidents of the Florida Federation of Square Dancers shall become permanent delegates, etc."

Article V, Voting, change Sec. 1, 2, and 3, to clarify and simplify without any change in meaning.

Section 1, Regular delegates will have one vote per person.

Section 2, Permanent delegates will have 1/2 vote per person.

Section 3, remove and change last two sentences. now reads--They will have two votes (clarified as one vote for each person). A single delegate would have one vote.

change to read--They will have one vote per person.

#### Constitution:

Article X, Section 1, Dissolution--reword to be more consistent with the Articles of Inc. and to simplify.

- a. To any recognized not-for-profit organization in any proportion deemed advisable.
- b. In no event shall the assets be distributed to any officer, delegate, or employee of the Corporation.

Original (a), removed, (b), the word charitable was removed and changed to (a), (c) is now (b), no change.

#### RECOMMENDATIONS

- 1. All documents be stored on a floppy disc or CD and kept with the records of the Corporation with the Secretary.
- 2. All future suggested changes to the documents be submitted to a committee to review for correctness and compatibility before they come before the Board of Delegates. This committee could be added to the list of Standing Committees.

  This would:
- 1. Avoid some of the misplacement of items in the documents.
- 2. Correct and simplify wording to be consistent with the balance of the documents.
- 3. Review suggested changes as they may conflict with non-profit corporation statutes or other parts of the documents.

Our next dance will be held at the Whirl & Twirl Hall on June 30 with John Swindle calling and Phyllis Williams cueing. If you are not aware, Phyllis lost her husband K O after a long illness. This will be one of her first appearances since her loss.

The Shamrock Swing for 2001 was held over the weekend of March 9 & 10, with better than 40 squares in attendance. For a first time weekend dance that we expected to lose money on, this was a huge success. We made money! Tim Marriner and Whit Brown called both plus and advance in two halls and Jimmy and Carol Griffin taught and cued all levels of rounds. We want to thank the other Area Associations for all of their help in publicizing and attending this event and making it such a success.

The Shamrock Swing for 2002 will be held on March 8 & 9 at St. John Vianny Catholic Church in Orlando, with Tony Oxendine & Whit Brown calling and Jimmy & Carol Griffin cueing. Good hotels and restaurants are nearby and we are looking forward to this great weekend with George & Shirley Knapp as Chairman.

Planning for and recruiting of committee people for the 2004 State Convention is proceeding on course. You will hear more on this from General Chairman Bruce & Colleen Morgan very shortly.

Article VI, Section 1, The Board of Delegates shall choose from among themselves a governing body of officers, that shall be known as the Executive Board. **delete this section,** THIS SECTION SIMPLY MEANS THE EXECUTIVE BOARD WILL BE SELECTED FROM THE DELEGATES. NOT SURE HOW THIS WILL IMPACT THE FEDERATION IF DELETED. ALSO IF DELETED THE ARTICLES OF INC. MUST BE CHANGED AS THIS IS FILED WITH THE STATE AND HAS THE SAME WORDING, ARTICLE 5, SEC. 3.

(proposed Article VI, Sec. 1,

The President shall appoint a Nominating Committee prior to the Annual Meeting. The Committee shall present a slate of Officers at the Annual Meeting. The Nominee for Parliamentarian (presented by the Nominating Committee) must be approved by the Executive Board of the Nominee's respective Association, and such approval must be in writing. THE ABOVE IS THE SAME AS THE CURRENT ARTICLE VI, SEC. 2., THE FOLLOWING IS NEW.

In the event that the designated Association submits two Candidates, it must provide the Chairman of the Nominating Committee with the names, Resume's and any additional evidence of Service to their Association and to the Federation. Based on its review of the resume's of each Candidate, the Nominating Committee shall select the one it has deemed best qualified for the position of Parliamentarian. THIS PUTS INTO WRITING A PROCEDURE FOR THE NOMINATING COMMITTEE WHEN MORE THAN ONE CANDIDATE IS BEING CONSIDERED.

proposed Article VI, Sec. 2(previously Sec. 3)

At the Annual Meeting each year, the first item of Old Business shall be the Report of the Nominating Committee, which shall list the Nominees from each of the five Member Associations for the positions of: President, Vice President, Secretary, Treasurer and Parliamentarian. THIS PROPOSAL REMOVES "AND AFTER WHICH THERE WILL BE A CALL FOR NOMINATION FROM THE FLOOR FOR EACH OFFICE," ETC., THIS CHANGE WOULD APPEAR TO REMOVE THE ELECTION PROCESS AND MAKE THE POSITIONS APPOINTIVE.

proposed Sec. 4 becomes Sec. 3

Section 3, The President will cause an election to be held for each office and the candidate receiving the majority of votes for the office will be elected.

AS THE NOMINATIONS FROM THE FLOOR HAVE BEEN REMOVED ABOVE, THERE IN EFFECT WOULD BE NO ELECTION. WE COULD REMOVE OR REWORD THIS SECTION TO GO DIRECTLY TO THE INSTALLATION OF NEW OFFICERS, WHICH IS THE OLD SECTION 5.




