#### Report to Federation Meeting October 31, 2004

First we would like to congratulate Colleen & Bruce Morgan on the great job they and their committee did planning and hosting such an excellent 50<sup>th</sup> Anniversary Party last May. It was fun and very well planned. It will be a hard act to follow!

After our FUN kick-off we received many calls and emails of congratulations on a short, to the point, and unique kick-off that everyone said delivered a message. We want to thank all those who took the time to give us your positive comments. We had a lot of fun putting it on and are now hard at work to try to make sure the 2005 State Convention is a FUN weekend. We do need to thank some people for helping us out – we could not have presented this kick-off message without the assistance of the Federation Board, our engineer from the Central Association – Larry Heffner, and Bruce and Colleen Morgan, who worked tirelessly to help us pull the event off.

We had a full committee meeting in September and found that the Chairmen were well in control and most all the planning had been finished. We are in the process now of bringing together the people to help on the various committees, as well as getting all the props and incidentals completed. I guess you could say we are bringing everyone and everything all together!

Following the Hurricane on the Labor Day weekend, we were approached by the Lakeland Center about releasing the arena on Saturday evening (the only weekend we had it reserved). #### 2006 Convention Report October 31, 2004

#### USDA ANNUAL MEETING REPORT TO FEDERATION MEETING OCTOBER 31, 2004

The annual meeting of the United Square Dancers of America is held in June each year at the National Convention. All four delegates from the Florida Federation, Jack and Barbara Hoffman, Charlie and Val Newsome, attended the 2004 meeting on June 23<sup>rd</sup> at the Doubletree Hotel in Denver, CO.

After the invocation and pledge to the flag, several visiting dignitaries from the 53<sup>rd</sup> and 54<sup>th</sup> NSDC the NEC, Callerlab and Roundalab were introduced and spoke briefly.

Minutes were approved, and Treasurer's report filed for audit.

Charlie Holley, Vice President from Central Region, presented one application for affiliation, the Kentucky Association of Square Dancers with 2 votes. The delegates unanimously approved them for membership.

Reports and committee chair reports were given with most being general information. Following were of interest:

CREDIT CARD – The third distribution of funds was presented to the Affiliates. Charlie Newsome accepted a check for \$400 for the Florida Federation. This represents \$100 per vote. The credit card program was started in 1989 – if you want to apply for the credit card and help your Federation, see us and we'll get the information to you.

BUDGET – Was presented by Dave & Shirley Nihart and approved.

YOUTH – Scholarship was presented to Paul Connelly from Lower Waterford, Vermont in the Eastern District Square Dance Association. He is an extremely talented and dedicated young man and has been involved in square dance activities all his life. Since Paul was participating in an exchange program and was in Germany his mother accepted the \$500 scholarship for him. There were 6 applications this year and they had come from the North, South, East and Western parts of the United States. The report indicated that all applicants were extremely qualified, making the hob of the committee for the Youth Fund Scholarship more complicated than ever.

A goal of the Youth committee this year is to give Youth Square Dancing a new look! Greek Letters were introduced and will be on tee shirts and ribbons to help emphasize our thinking.

NATIONAL FOLK DANCE – Delegates voted their approval to go forward to the next Congress to get this vital bill passed. Twenty-nine states have now sponsored the bill.

Next came the election of 2004-2005 USDA Officers. Retiring from the Treasurer's position was Dave & Shirley Nihart who received a round of applause for a job well done. Bill Flick, Eastern Region was elected to that position. Others elected were, Jim & Edyth Weber, President, Lenny & Connie Houle, VP from Eastern Region, Kitty & Charlie Holley, VP from Central Region, Michael & Kimberlee Streby, VP from Western region, John & Alitia Becker, VP from Plains Region, and Si & Marilyn Kittle, Secretary.

A new long-term care insurance plan for USDA was presented and approved by the delegates. We have some of the long-term care tri-folds on order to give you more information.

The delegates also voted approval for the Beckers and Holleys to review Youth Applications for Scholarships.

After the installation of the 2004-2005 Officers, and the Recognition of 2003-2004 Executive Committee and Board of Directors, the meeting adjourned at 3:22pm

#### Florida Federation Insurance Report October 31, 2004

As of September 30, 2004 we have 76 clubs and 3373 dancers insured. This is an increase over last year. I'll give you a year end figure at the working weekend in February. I HAVE RECEIVED PAPERWORK FROM ALL SEVEN OF THE ASSOCIATIONS THAT WE INSURE.

The 2005 insurance package has been received form the USDA. You will be happy to know that the rates for the coming year have only gone up to \$3.90 per dancer. The minimum rate for a club is staying the same at \$45.00. The only major change this year other than the price, is that the clubs have to list their class members on a separate sheet of paper, and they have to provide a starting and ending date for their classes. As in the past, there is no charge for the class members but they have to be submitted. If they are not submitted they are not insured even if they are members of the class. After the class graduates the club has to resubmit the graduating class members again on the regular listing as regular club members along with payments. If they are not re-listed after the previously submitted end date for the class these members will not be insured.

The 2005 packages must have been mailed or delivered to each association insurance chairman and the association chairmen are actively working to get their dancers insured. That is all but the Cloggers. I have called and emailed Michelle Roberts a number of times but have not received a response. I am not going to mail the package to her until I hear from her letting me know that she is still the insurance chairman. This past year another lady tried to take the job over, when Michelle did not respond. As soon as that happened Michelle sent in her paperwork. That is the paperwork for all the clogging clubs except for the club that this other lady belongs to. I called the other lady and had her send her paperwork directly to me. Just because there is a situation in the clogging organization there is no reason for dancers to go uninsured.

The choice should include a brief autobiographical sketch and at lease 3 events at which the caller/cuer has demonstrated his or hers contribution to the square dance activity.
- 3 The selection committee to meet during the February working weekend to review the nominee(s) and arrive at a final decision.

#### PROCEDURE FOR PERSENTING AWARD(S):

- 1. The award(s) should be presented at the following Florida State Square and Round Dance Convention by the current president of the Florida Federation.
- 2. The award(s) presented shall be a framed document and an "Extra Mile Award Recipient" bar or dangle.
