The Grapevine Report Florida Federation May 27, 2007

The Grapevine is alive and well in the Northeast and is picking up more energy with each passing week. The transition between editors Bob & Jane Raymond and Sarah & Charlie Pergrossi has been smooth and is now complete. The Association held its 5th Saturday Dance on March 31st and it served as a Subscription Dance to *The Grapevine*. This event was very successful resulting in 93 new and renewal subscriptions by the end of the evening. Our subscription base has shown a slow but steady increase since this event.

During the transition between editors and the moving of the bulk mail facility in Jacksonville, we learned that the post office offers several free services to its customers. One such service is a design review to see how we might save money on bulk mailings. We learned that by making a few minor design changes we can mail at the letter rate rather than as a flat. We will realize a savings of 5¢-10¢ per piece, and this is after the postage increase of May 14th! Since we'll be mailing approximately 275 pieces of mail, this savings is significant.

Since we live on the west coast of Florida, we have selected to use a local printer instead of one in Jacksonville. With the assistance of this new printing company, we will try a few new ideas to enhance the quality of the magazine. We will go to print on our first issue early in June with a mailing before departing for North Carolina and the National Convention.

Our ad policy remains unchanged, but we have adopted a single tier ad charge. This means everyone pays the same amount per ad, instead of an association member and nonmember rate. To celebrate our new venture as editors, we are offering a 10% discount towards the cost for all nonchanging ads taken in four consecutive issues with payment in advance. The majority of our regular advertisers have already taken advantage of this offer, with others considering it for future issues.

We continue to print all the news we can find about Square Dancing...which includes rounds, contra, country western and lines. We will make sure to include as much information as we can get about both the State & National Conventions. We will include all major dances of the other Associations in our Calendar of Events, so please pass along your information to us. Our Calendar of Events is available in each issue as well as online. The calendar is updated monthly on the Florida Square Dance web site (http://www.floridasquaredance.com/northeast/index) and on our Pergrossi site under The Grapevine (http://pergrossi.com/grapevine.html).

We've tried to contact the other Association Editors to discuss the policy of printing exchange flyers to advertise each association's annual festival and we're awaiting their replies. We believe this free exchange of flyers benefits each association and ultimately our dancers. Our deadlines are the tenth of December, March, and September. The July deadline is the first of June in order to provide sufficient time for publishing before attending the National Convention later that same month.

Historian Report

Good Morning,

Tim & Terri – Excellent Convention-Outstanding

Paul & Cheryl – Great Fashion Show & unique way of getting Birds & theme into the Fashion Show – Different – You left out our National Bird, one of my favorite birds – The Mocking Bird – from Texas – maybe next year.

PeeWee & Mary Stewart – 53rd Convention & holding. History in the making.

Sherry and I have learned a lot in just the short time we have been Historians. Jack and Zonie Taylor envisioned the need to preserve the state history of square dancing. The present history will become our legacy.

Unless you worked with these books, touch them and flipped through these pages of history, you can't know the hard work created an accomplished by Jack and Zonie. The research and maintenance of the square dancing history can be pleasant and fun. You meet a lot of people without leaving your home. You meet people you have never seen and probably never will; but you know a little history about them. And what they did then and what we do now to preserve the history of square dancing will become the legacy of square dancing.

Don't confuse tradition with legacy. Traditions may die on the vine if we let it or dare to make changes to it. But legacy - is tangible - what it becomes now can not be changed.

We need a positive and proactive approach to the preservation of history otherwise we will have a negative result in our Square Dance Legacy ---

A special historian committee was held on May 26, 2007 (Saturday) at 9:00 A.M. The purpose of the meeting was to discuss the disposition of the State Federation History records and memorabilia. Committee members were:

Manny and Sherry Gonzalez Jack and Zonie Taylor Ken and Sandy Brasfield Mary Butlak The historical inventory contains many albums of photos, articles and various correspondences. Other items are the collection of each association's publications; with Bow & Swing having the oldest history. A couple of the associations started their publications but changed the name of the publication as it was passed along.

We also have a collection of the state convention dress/clothing as it was designed and adopted each year by the Association cheering the state convention.

Additionally, we have buttons, banners, and souvenirs collected throughout the years. We have paintings that were donated depicting the theme and/or era of the time.

It was the intention of the committee to develop probable solutions as to the maintenance and care of the historical records. There upon making a recommendation of the best possible solutions to the President of the Board, members of the Board, and delegates.

1. First and foremost, we should not make hasty decisions to eliminate any historical records for the sake of reducing the inventory of the items, materials, correspondence, and records to make it more palatable or as a way to induce a person or couple to accept the Historian Chair.

2. Rent the storage facility in size of $5' \ge 5' \ge 8'$; to be climate controlled and accessible to the committee and board. Store items not required as routine "working" history records. Working records consist of notebooks albums and convention display items for the showcase. List:

- i. Display items include:
 - 1) backdrop -- canvas painting
 - 2) plaque for national convention chairman

3. Recommend the President appoint a committee chair to investigate procedures and/or methods of electronically transposing/scanning applicable and appropriate historical records onto CD's or appropriate type of preservation method to secure, preserve, and maintain the historical records.

- a. The investigation and/or study should include the feasibility of having such procedures contracted to a reliable firm and cost for such procedures plus the annual accumulation of the current records of each year, as records for each year are processed.
- b. Research the type of equipment required to display and/or project the CDs/DVDs onto a screen for presentation of the history photos or articles at the Square Dance Convention.

Equipment should be user friendly and able to provide maximum display activity for viewing. The study should also include the cost of maintenance of equipment, cost for materials such as ink cartridges, CDs, service warranties etc.

4. When the above are accomplished and a new method of preservation of the historical records are secured in a satisfactory procedure; Then the committee should make a positive and serious consideration of what records, publications, articles, and memorabilia to be maintained by the Historian and what is to be returned to the associations for their disposition.

<u>Recap</u>: The committee recommends that the Board and Delegates not make any hasty decisions to in any way reduce, condense, or attempt to eliminate any part of the historical records as they are now.

Store those historical records that are the non-working files or archives on a temporary basis in a climate controlled facility. The cost per my research is \$50 plus or minus per month for a 5' x 5' x 8' storage facility. Facility can be rented on a monthly basis without an annual contract agreement.

Appoint a committee to conduct a study to transform/transpose those applicable records/photos into a better secured method of preservation and in turn condensing the bulk to CDs or similar methods. Determine the cost for contracting or purchase of equipment. The caveat to this is that if equipment is purchased for use in displaying or projecting photo/records on a screen, that the equipment is user friendly and cost of parts, ink cartridges and supplies are not prohibitive. Maintenance contracts and warranties should be considered

Manny and Sherry Gonzalez Historian Committee

Motion:

Manny Gonzales made a motion that we rent a climate controlled storage area on a monthly and temporary basis not to exceed \$60 per month, on a temporary basis until such time as a study is completed for further disposition of the historical records and methods are approved by the delegates. Donna Hendricks seconded motion.

Call for Questions:

President Sue Brown called for questions from the floor.

Anita Taylor questioned: This is a cost of \$720.00 per year for now? Manny reiterated that based on his research it would be \$50.00 per month or \$600.00 per year, however, it may not take a whole year, it depends on the committee.

Jack McKinney asked: When is the committee meeting again? Manny responded the President is going to appoint a Committee to research the preservation of the records. I am not sure when the committee will meet, but I would recommend it meet post-haste on that.

From the floor: Where are the records presently at and why can't they remain there? Manny responded "They are in the hall right now, they were in our home and previously they were at Jack & Zonie Taylor's home.

From the floor: Why are they in the hall? Because we have since resigned as Historian's, our personal & private agenda has made it so unfortunately otherwise they would still be there and we would be talking about it right now.

Ray Huddleston: Where are you going to rent this storage facility? Manny stated; he has researched here in Lakeland and Mulberry not too far from here, and if you went to one of the other towns, I anticipate the cost to be more than \$50-\$60 dollars. I did ask if we would have to sign a year contract and was told "no" we could go on a monthly basis, the fees as follows; one time Administrative Fee \$10.00 to put your items in storage and monthly Rental Fee with 30 day notice.

President Sue Brown stated the best place for the storage is close to the committee. **Colleen Morgan** stated that \$50.00 a month to preserve these items.

Call for Vote:

The President called for a vote. Passed with no opposition. Motion carried. Committee would be appointed during new business.

Florida Federation Insurance Report

As of April 30th we had a total of 2555 dancers from 68 clubs insured. Last year at this time we also had 3110 dancers from 75 clubs. We lost 7 clubs and 555 dancers this year.

I think all the clubs that are going to insure have probably sent their paperwork and payment in by now. There will be a few more dancers that will trickle in between now and the end of the year as clubs complete their classes and the students join the clubs. But that won't amount to very many.

Something that has come up since my report, the Southeast Insurance Chairman Jerry & Helen Rhodes asked; What is going to happen to the Southeast Dancers when the Southeast Association disbands? Well each association pays \$50.00 dues to the Federation to be a member of the Federation and so they can have insurance. Until the Federation reorganizes. I recommend that the other associations absorb the dancers. We do not want any dancers to go uninsured while we wait for the reorganization. Ray Huddleston stated that he understood that from a prior meeting that Central would pick up the dancers. Bruce stated; It doesn't matter how it gets done, we just want to make sure that any clubs and dancers don't go uninsured, whether they get picked up by Central, West Coast or if they continue to report under Southeast. Their Insurance is valid thru December 31 so come January 2008 the Federation will have to make a decision on which association will pick up these dancers or how these dancers will be insured.

Convention Facility Search Committee Report

We are in the process of completing the paperwork for the next two conventions and if the Board wishes, we will follow through on these to completion.



Back in May of 2006 the Reorganization Committee reported on a motion to Amend the State Convention By-Laws. And in so doing we had 2 motions; the first one was to revise the method of paying for the website; we are not going to get into discussion regarding these motions, as they were made, discussed and passed by the Federation at earlier meeting. The second motion consisted of three parts: With a fourth contingent upon approval by either the Callers Association or the Cuers Association. The Cuer Association approved the 2 stated motions. We received acceptance from Beverly Landwehr, President of the Cuers Association. (Motions and Cuers acceptance are included for the delegate's records.)

COORDINATING COMMITTEE REPORT TO THE FEDERATION

One other item I need to mention and that was at the Coordinating Committee Meeting yesterday. There was a motion made and seconded to eliminate the Coordinating Committee and transfer its function to the Federation. After much discussion, this motion was voted to be tabled until the next meeting in May 2008. This will give the three organizations time to discuss it and report their recommendations to the Secretary of the Coordination Committee for committee review. This is not entirely a reorganization committee function; being that we were at this meeting, we were given this task.

But right now, we have nothing in writing as to what their feelings are at this time. The Federation feels that it should be disbanded. And that is our report.

COORDINATING COMMITTEE REPORT TO THE FEDERATION

A meeting of the Convention Coordinating Committee was held Saturday May 26, 2007 in the Lake Parker Room at the Lakeland Center. All but two members of the committee were in attendance and the meeting was conducted by the Chairman, Conrad Protzman.

Reports were given by the Chairman of the 53^{r1}, 54th, 55th and the 56th Convention. There was was no old business to conduct.

Under new business, Jim McConnaha reported on the search for a new site to hold the convention. He reported that for all of the sites he and Jan had looked at, the Lakeland Center was still the best choice. He then reported on their meetings with the City of Lakeland Deputy City Manager and his help in trying to resolve our problems with the Center. He also advised that the Convention and Visitor Bureau had approved a \$2400 grant to this year's Convention. George Knapp then reported on the changes that the Federation and the Cuers had voted to accept.

There was a motion made and seconded to eliminate the Coordinating Committee and transfer its functions to the Federation. 3. The Florida State Square and Round Dance Hall of Fame and the

<u>www.floridasquaredance.com</u> web site shall be funded by The Florida State Square and Round Dance Convention utilizing the following criterion. The maximum amount of seven hundred fifty dollars (\$750.00) may be contributed to the Hall of Fame and the total cost of the web site.

The net proceeds of the State Convention shall exceed \$7,500.00 and the contributions will not reduce the net proceeds to less than \$7,500.00.

The Hall Of Fame Committee shall provide a financial statement and the we master an invoice to the Treasurer of the State Convention at, or prior to, the Convention

The net balance in the Hall Of Fame shall not be more than \$1,500.00 in order to receive the contribution. The amount contributed shall not increase The Hall Of Fame balance in excess of \$1,500.00; otherwise the contribution is adjusted downward so as not to exceed that total. These contributions shall not change the Host Association's normal share of the State Convention proceeds. The Treasurer of the State Convention, utilizing the criterion above, will make the contributions from the net proceeds before a division is made.

E. The net proceeds are distributed as follows: Subtract one-third of the total amount

She is much younger and so energetic that I feel she would be a welcome addition to the planning of this convention. And besides, we really need to get these "youngsters" involved.
