Parliamentarian Report

Florida was well represented with dancers at the National Convention in Charlotte in June, 2007. States were allowed only two squares of dancers to participate in the Parade of States. Florida's dancers looked nice in the Parade of States on Saturday evening, with everyone wearing the current Blue/Green & White Federation attire.

During the ceremonies following the Parade of States, Florida was presented a 25-Year Certificate of Appreciation Award for our participation in the National Convention Showcase of Ideas. Since that we have found out that the Federation has participated for 36 years and we will work to get this corrected at the National Convention.

At the Showcase of Ideas we received many positive comments about our new backdrop. A couple of people wanted to know where they could obtain one like it and we were happy to pass along the Company's name and address. We also had many people from other states stopping to write down the places to dance in the various counties. Comments were made that they liked our idea of the maps on the black boards showing the areas in Florida where the dances were. We'd asked for flyers of dances in each Association to be placed on the table in front of the black information boards and some were there -- but we could have used many more flyers of upcoming dances.

Another item of interest to passing dancers was the table drape advertising the 2008 Convention. We can't take credit for that as Don & Ann Slocum called and asked us if they

could display it in the Showcase. Since we thought it would be a great idea, we did it. Note to future convention chairs.....look at the table drape the 2008 convention has. It serves multiple purposes and sure looked nice on the Federation Showcase table. It would be nice to continue advertising our State Convention on the Federation Table at the National.

Giveaways at the Showcase were from leftovers of other years -- (l) the grapefruit magnets and (2) the engraved pencils. All the grapefruit magnets were given away, and there is approximately one and one-half boxes of pencils left. Next year, we will have to purchase whatever we give away. In addition to those items, the Northwest brought all their leftover Convention buttons and some leftover pink flamingo pens; and both went like hot cakes! By far, dancers want pins representing the various states at the National and we'd like to recommend that next year's Parliamentarian try to obtain a really nice pin of the State of Florida for our giveaways.

We experienced no problems during the Showcase time. Most tables were unmanned except for the opening morning. We continued to check our tables, keeping it clean and restocking the baskets of giveaways about 3 times daily. We had plenty of help setting up and taking down the display. We thank everyone who was there to help.

We enjoyed working with everyone on the State & National levels for the Showcase of Ideas, and thought both the Showcase at State and National was beautiful and well received. We also enjoyed being a part of the Parade of States at the National.

Disbursement of money received from Grand Squares, Inc.

The Central Florida Association decided to purchase magnetic signs, to be place on cars, SUV's, trucks, to promote or educate people about square dancing. These will be given to the Area Directors to distribute among their many clubs and members.

The signs were made by Dynamic Seven, Inc. in Titusville, Florida, and have black lettering on a white background. They measure 4" high by 14" long. A quantity of 200 pieces were made at a cost of \$402.80, includes tax, or \$1.90 each. (A copy of the invoice is attached.) We received a total of \$355.20 from Grand Squares, Inc. but the CFA had already agreed to pay the difference up to \$400.00, if needed, to complete the purchase of our project. \$45.80 was needed from the CFA Treasury. The yearly web page maintenance fee of \$9.95 will be paid out of the CFA Treasury, also.

Interested inquires would be sent to the publication and then forward to the club closest to the individual's home address, which will be followed up with a personal call from the club representative. This will help document in what areas could possibly be class locations. And get the clubs to initiate these classes.

We also received a tri-fold sample from Panama City advertising the health benefits, fun and social activity of Square & Round Dancing. This colorful tri-fold has been reproduced by our Panhandle Press to each of our clubs. Clubs are able to design their tri-fold to advertise their areas. Pensacola is designing theirs around Five Flags and the Naval Air Station. These tri-folds maybe left in Doctor's & Dentist Offices, Chamber of Commerce, Senior Centers and Libraries. We are checking with area Visitor's Centers & Realtors for Newcomer's packages.

Because of personal reasons, effective immediately Colleen and I will be stepping down as Florida Federation Insurance Chairman. This will be our last report.

Randy & Carol Poole have agreed to handle the USDA Insurance until a replacement can be found.

Carol Poole stated that next years Insurance Rate will be the same as this year. She encouraged all the Insurance Chairman from each of the 5 associations to attended the Working Weekend and sit in on the Insurance Committee.

U.S.D.A. Report

The annual USDA meeting was held at 1pm on June 27.2007, before the National Square Dance Convention in Charlotte, North Carolina. 129 delegates signed in. Executive Committee Members: 28. Guests: 23. Total number of attendees signed in 178. This record of attendance at the USDA meeting I obtained from the USDA secretary.

During the past year, we have been promoting the United Square Dancers of America by displaying Publications and Literature and attending special dances in and out of Florida. The USDA President gave us permission to do the two education material displays. (filling in for a sick person), outside of Florida.

USDA has produced four new tri-folds during the last year: one on parliamentary procedure, entitled Parli Pro; How to conduct a meeting; one on the On-line Shopping Mall; Youth Competition Dancing Information; and Dancers Code of Ethics & Conduct.

69,787 visits to USDA Home page between May 8, 2006 and April 30, 2007. Lowest one was on-line shopping 185. The most was Publications and Educational material 10,582.

Next topic: ARE YOU DANCING UNINSURED

This appear in all the publication of the USDA (reference USDA NEWS Volume XVIII, Issue 4 Oct. – Dec., 2007 "ARE YOU DANCING UNINSURED"). There is a lot clubs that are dancing as Caller Clubs, these clubs are questionable if they are dancing insured or not.

At the National Convention I was talking to the USDA President about caller clubs not having USDA insurance coverage for the Square dancers. If the caller only has Callerlab Group Liability Insurance, the dancers are not covered by this insurance. I was talking at this meeting to Bob Barnes, and he was saying that there is an additional insurance that a Caller can have to cover the dancers. But here is what I got from the USDA President, who contacted the Callerlab, who sent this to the USDA President who forward it to me (reference CALLERLAB GROUP LIABILITY INSURANCE (July 2007) Coverage Highlights:) Dancers are not covered by this insurance. If a caller has additional insurance, I would like to see this insurance. I am the PASCO County Rep. and we have Caller run clubs and I would like to be able to inform these dancers if they are covered by insurance or not. If you would like a copy of this, that the USDA President sent me, it is available.

ARTS

ARTS-Dance

ARTS is planning a Nationwide Benefit Dance on Friday, February 29, 2008. Dance Across America. They hope to raise enough money to help improve and expand all areas of dance activities through research, marketing and education. You can go to their website and have them list your dance in their log for Dance Across America. And order some brochures to pass out at the dance so everyone can learn more about ARTS. Many dances are already scheduled across the country.

ARTS will request each dance to play "God Bless America" or "God Bless the USA" at specified times across the nation during the dance so that it will be sung and/or danced to at the same time across America.

Everyone who attends will be asked to sign in and these sign-in sheets will be sent with the donations to ARTS so that ARTS can apply for the Guinness Book of World Records. The premise is to get recognition across to the general public of our Traditional dances. Any club that already dances on Friday night can participate by collecting a donation for ARTS and sending it in along with their sign-in sheets. There is still time to plan a dance in your area.

ARTS has received a couple of significant donations. They received \$1,000 from NEC. It was their share of the raffle at the 56th National Convention in Charlotte, "Share the Wealth". ARTS also received a \$10,000 donation from the Playground Area Round & Square Dance Organization in Fort Walton Beach upon the dissolution of that organization. The Alliance of Round, Traditional, and Square-Dance (ARTS-Dance) is a 501(c)(3) tax exempt corporation. At the last meeting I attended, the Federation in Iowa had setup a way to help clubs get back on their feet was by giving clubs grants to help with classes. The guidelines for the money were very specific and very equitable. Possibly our Federation could look at doing this or the Association in the clubs area could assist the clubs with grants. It is something to think about. I have all the information on it if anyone is interested in this.
