The goal of this committee is to find a viable way to save the history of the

Florida Federation and do so in a more manageable form. It is a wonderful collection of clothes, publications, convention albums, program books, etc. - most out together lovingly by Jack and Zonie Taylor and our desire is to keep all intact.

We need to preserve our paperwork, also our meeting minutes, financial records, Articles of Incorporation, By-Laws, Standing Rules, Constitution, etc.

We would like to purchase Macro Media Flash software to scan all the above items on discs, making two copies each; one master to be held by the Florida Federation Historian and one for use by the Federation delegates. When all the history is scanned, the items will be returned to the associations where they belong, to do with at their discretion. The material is now stored in a 5x5x9 shed in Lakeland at \$51.36 a month and will have to stay in a storage unit until it can be scanned.

Donna Hendricks and Bruce Morgan have volunteered to scan all items and put them on discs. Bruce has volunteered to put the history on our website.

Our future desire would be a "picture frame" that could be used at conventions and other promotional sights.

We, the History Preservation Committee, would like to make a motion to purchase Macro Media Flash and discs for an amount not to exceed \$1,000.00.

Bruce Morgan requested moving the stored items from Lakeland to an area nearer his location for convenience as this project proceeds. Bruce Morgan also said the history could be put on the website. He said pictures could be put on picture frames and displayed at conventions; however, this suggestion was not pursued due to the possibility of theft. It was suggested that some articles could be given to the historical society.

PRESERVATION, EDUCATION & PUBLICITY Square Dance Preservation, Education, Service, combined with Public Awareness and Publications

The breakout meeting met at the LaQuinta, Maitland, FL; room 331 at 10:00AM Saturday, March 8, 2008. In attendance were George Knapp, Central; Aileen Picheco, Central; Smitty Smith, NE; Bessie Stovall, NE; Penny Green, WC; Mary Lee Van Valkenberg, WC; Mike Ziegler, WC; Miriam James, WC and Chaired by, Kathy McKinney, NE.

We met and at first thought said "Are we one of the breakout committees that was suggested should be dissolved?" "Do we do the same things over and over?" "Do we have the same results over and over?" "Do we have the same results over and over?" We decided the answer to those questions was "Definitely, YES!" However, is it a fact that little by little people learn about square dancing through our promotional efforts? Again the answer was "YES!" Therefore, we MUST continue our efforts! Why not? Most things we do cost very little and provide goodwill, fellowship, and bring us a sense of pride to ourselves and our organization!

EFFORTS: We asked of all our efforts, what has been determined to be the most effective? Here are the top 3 we came up with:

1. INTERNET: Publications, web sites, emails, and other links are all so very important in today's times. Publications such as DANCERgram, The Grapevine, PanhandlePress, etc.; web sites such as Floridasquaredance.com, Pergrossi.com, Dosado.com; and if you "Google" "Square Dancing" you will find many other sites with many links that are all great tools for us to utilize. Lisa Wall made the suggestion that perhaps we could look into "non-square dance" organizational sites that have family entertainment that would put our square dance links on their sites. This would provide information to "non-dancers" and hopefully entice them into our activity. Ouida Taylor, President of the NE, said her daughter was developing just that type of site and would welcome our links on her site. If anyone is

aware of someone in our organization who has computer savvy they could aet us "linked up"!

- 2. BUSINESS CARDS: personal and club cards are easily distributed along with "You Have Been Patronized by a Square Dancer" cards. In that vain, the USDA offers "prescription discount cards" that can be used by anyone. You can give them to people like waitresses and service people who do not have benefits. These cards will do more for them than a "patronized card" and they will remember a square dancer helped them in time of need.
- 3. START LESSONS MORE OFTEN: Try your best to get you club and/or caller to start lessons more often. Whether it be 10-10-10 or A-B-C teaching format the current students appreciate helping others and their extra floor-time is reinforced. Gaining more students is vital because "they" are the ones most likely to bring new dancers to your clubs. We all know the bottom line is word of mouth and one-on-one communication is the best way to preserve square dancing and through the new and excited dancers is where it's at the second sec

In closing, I myself look at these few minutes at a breakout meeting as a stress and a stress an bonding with dancers from around the state as an impetus to carry on my EFFORTS! I enjoyed meeting in our group and I hope they did too. I am going home now, surf the Internet...and "Google" for some new sites to get "Linked Up" with! Old Business

President Poole announced that he had made one addition to the committee he appointed Saturday, March 8, to review the feasibility of discontinuing the annual working weekend. In addition to Val Newsome, Jack Hoffman, and Mary Lee Van Valkenburg, he also appointed Dewey Hendricks.

Randy Poole said that when GSI took over the Winterfestival, the Federation agreed to try working together with GSI for two years. He asked if we want to continue working with them and get the \$500 a year. He said no one is committed to go. Five packets are given to each association, and there is no pressure to sell ribbons. Jack Hoffman moved to continue the relationship with GSI. Motion carried.

New Business

Ann Slocum said many delegates have spoken with her stating that they do not believe one association should get the profits from the dance held on the working weekend, and that the working weekend should not be connected with the Shamrock Swing. She made a motion that the working weekend should be a weekend the Federation chooses from January 1 to the first weekend in March, and the funds should benefit the true state convention starting next year to benefit the 2010 Convention. A lengthy discussion followed regarding who would be responsible for the dance arrangements, date of weekend, having a one night dance as opposed to an all weekend dance, possible profit to the upcoming convention of about \$400 - \$500, and less work to set up a one-night dance, and the possibility of Randy appointing a committee to review the issue. At this point Erv Oermann called a question to end discussion. After a vote in favor of ending discussion, Ann restated her motion as follows: That we have the working weekend starting next year with the location set by the Federation President for the last weekend in February and arrange for a Saturday night dance to benefit the upcoming state convention. Motion passed. The location will be announced at the May meeting.

The next Federation meeting will be at 9:00 a.m., May 25, in the Lake Morton Room of the Lakeland Center.

Meeting adjourned at 10:45 a.m.
