Internet is being recorded as \$120.00 which is about the sane as last year Our interest was \$1.00.

#### **Expenses**

President paid out \$19.89 last year. We are proposing a budget of \$100.00 this year.

Vice president paid out \$236.33 last year. We are proposing a budget of \$250.00 this year.

Secretary paid out \$34.68 last year. We are proposing a budget of \$75.00 this year.

Treasurer paid out \$38.17 last year. We are proposing a budget of \$70.00 this year.

Parliamentarian paid out \$160.57 last year. We are proposing a budget of \$100.00 this year.

USDA paid out \$100.00 last year. We are proposing a budget of \$100.00 this year.

Corp. Tax was \$61.25 last year. We are proposing a budget of \$61.25 this year.

Honorariums paid out \$75.00 last year. We are proposing a budget of \$250.00 this year.

### c. Public Awareness, Publicity, Preservation, History & Education.

## History, Education, Public Awareness, and Preservation Committee Meeting Saturday, January 13, 2018

### **History**

Penny has inherited some square dance files from a former member of Buttons & Bows of Lakeland who became a member in 1958.

Larry and Dorry kept every issue of Bow & Swing and the West Coast Dancer they received. As many of you know, Bruce has uploaded all the copies of the Bow & Swing and the West Coast Dancer that he could find, but there were some missing issues. Penny was able to locate the missing issues. There were also some hardback books on square dancing, cassette tapes of Art Springer and Singin' Sam Mitchell calling were donated to the New England Square Dance Museum.

Larry and Dorry had also collected all the meeting minutes, financial reports, special event flyers and Knothead Konvention flyers. Bruce has digitized the Knothead flyers and uploaded them to floridasquaredance.com. Penny is in the process of digitizing all the paper files. There is also a collection of every badge and dangle they received and other miscellaneous square dance memorabilia.

Since this committee is a catch all of square dance related issues that don't fall under the other committees, we also discussed some additional issues.

In an effort to encourage our associations to exchange information with each other, a matrix was created listing all the association publications, *Bow & Swing*, *American Square Dance*, DANCERgram, floridasquaredance.com, *USDA News*, the deadlines to submit information to

each publication, and the name and contact information for each. A copy of the matrix was sent to the WC officers, the newsletter editors, and the convention chairman.

Penny has agreed to be the point person for the USDA email tree. When she receives communications from the USDA, she will forward them to each association president or designate. The president should then forward the communication to their respective distribution lists with instructions to keep forwarding the email.

West Coast, Southeast, and Northeast each have distribution lists. The three of them are on each other's distribution lists and they have been sharing information. Northwest has a list but it appears to only be used for information coming out of that association. As far as we know, Central does not have a list. Ailene and Penny are part of the ARTS email tree. Since the majority of the publications publish once a quarter, we need a way to communicate information to the entire state that can't wait until the next issue of a magazine. The DANCERgram distribution list is used to notify the dancers of dance cancellations, change of callers or cuers, joys and concerns, information that didn't make it into the weekly publication, reminders about deadlines, meetings, WC membership dances, etc.

Updating floridasquaredance.com should be at the top of the to-do list and should be a scheduled task that is completed every six months or once a year. Assigning this task to a particular position, like secretary, and adding it to the job description might ensure that updating isn't overlooked.

The New Dancer Handbook needs to be updated. Penny Green has volunteered to take over this project.

Some associations have been using yard signs to advertise classes. West Coast ordered **50** signs that state, "Learn to square dance" and there is a place to add a phone number. The signs are free to any club that requests them. Everyone is cautioned to find out the rules/laws for your area in regards to placement of yard signs or you may put them up and they'll be gone when you come back!
