The rate remains the same for 2019 at \$ per dancer. Each club and association will receive new USDA numbers. The club or association will get a new number each year. When a club enrolls the certificate receives the next number to be issued. All certificates for a club or association issued later in the year should have the same USDA number. We were glad to add a new club to the insurance program during this period. The Northeast Association's club the Salty Bobbers in Trenton.

To insure the Federation Board and Delegates and the Convention Board I need the most current and correct roster. I also need to know if the Ocean Center and the Gold Star Ballroom's contracts are in the Federation's name or the Convention's name. To all future convention chairman remember to ask about the insurance and to give me the information. The convention was in Lakeland for so many years I just typed up the forms. Only once did we have a change when Lakeland added the "The" to their name. Some major changes are coming to the insurance program. The USDA square dancers insurance has been administered and underwritten by Markel Specialty Commercial. They have decided to outsource this program. The outsourcing company (I don't have a name) wants us to do more online. The program is not up and running currently. They are still testing the program. The plan is to give us a link. They want each club to go to this link to renew/enroll. The club will type in the names of the dancers and the dance facility. To make it easier the company has already put in the names from 2018. New names would be typed in and some names deleted if they are no longer a member of the club. The company would then email the certificate to the USDA Insurance Director

(Pat). When she gets the money, she will email me the certificate. That is how it is supposed to work.

If a club does not have a computer, they can enroll the old way and the association chairman can enter them on the computer. If the association chairman does not want to do that, they will forward on to me. Pat said, "If I did not want to type in the names, she would have to do it!".

I don't know how we will catch duplicates. I find a lot of mistakes that I correct before sending it on to the USDA Director. Dancers Insured Through Another Club will be forwarded directly to me for processing.

Additional Enrollments will have to go to the link.

Thursday night Pat emailed the clubs would be keeping the USDA number assigned in 2018. She asked we be patient with the changes. She is learning also. That is how I understand what is happening and it is subject to change. If you have questions, please write them down and I will get with Pat to get the correct answer.

I was asked to hold off sending in renewals. The ones I've received I will practice with them when the system is ready. I will send Pat the money and we should get the certificate right away.

BMI/ASCAP November 11,2018

We had a question about using recorded square dances for demos. This is not allowed unless the club has their own BMI/ASCAP licenses.

Although most people buy digital audio files, CDs, or games like Guitar Hero thinking they are now their property, there is a distinction in the law between owning a copy of the music and owning the actual songs that are played. When you buy an audio file, software, or CD, even those specifically marketed for business purposes, the purchase price covers only your private listening use, regardless of how they are labeled. Once you decide to play any copyrighted music publicly, you need permission from the copyright owners.

A "public performance" of music is defined in the U.S. copyright law to include any music played outside a normal circle of friends and family. Songwriters, composers, and music publishers have the exclusive right to play their music publicly and to authorize others to do so under the copyright law. This is known as the "Performing Right". This right was designed to enable and encourage music creators to continue to create music.

When you see the words "All Rights Reserved" on a movie that you've rented or purchased, you know that playing that movie before a public audience is prohibited. The same restrictions apply to music that is purchased, broadcast, or live musicians that are hired to play in a public setting. Every business or organization must receive permission from the copyright owners of the music they are playing before playing it publicly.

- C. Flooring Committee Report given by Ed Drexel
- Our charter was to look at flooring options to be used at the Florida State Square and Round Dance Convention.
- Terry and I have attended the Tennessee State Square Dance Convention and have been in touch with the powers that be in Tennessee.
- We have talked to the Chairman of Tennessee as well as their tape supplier in NC.
- Based on the information we have received, it is slightly cheaper to buy flooring as opposed to rent it from Bob Bahrs.
- It has been our opinion that each Convention should purchase a portion of flooring (1 or 2

rooms) each year until we have enough to floor the entire event. This approach allows you to learn, grow an inventory and save money.

- This approach would stockpile flooring and in 3 to 4 years you would own enough to floor the entire event.
- It is our view that this approach is cost effective. Each room of purchase is cheaper than renting it. Even if you disposed of the floor after the event. It would be cheaper.
- Tennessee does not store the floor in climate controlled storage. It is stored in a barn.
- The idea of purchasing flooring has been 'lightening rod' for many.
- Who is going to put it down?
- Who is going to take it up?
- How do you transport it?
- "We're too old for this".
- Where are you going to store it?
- Square dancing is dying.
- Clubs all over the state are experiencing a sharp decrease in attendance,
- Attendance is down at special events.
- The dancer population is getting older by the day.
- Considering the state of square dancing in the state, and the overwhelming concerns that people have expressed, we will continue 'status quo' for the 65thFSSRDC.
- We will rent flooring from Bob Bahrs, even considering the falls we had last year.
- We will utilize the available Ocean Center flooring.
- We recommend reevaluating this for 2020.
