The committee was asked by the President of the Federation to discuss the situation where a square dance hall requested donations to assist in making repairs to their building that was not covered by insurance and they did not have the funds to meet those demands. The Federation donated \$1,000 to assist this hall. At the same time there was another dance hall that required funds and received nothing. But the hall that was needing funds never requested assistance, so the Federation was unaware of any such need. It was decided by the committee that the Florida Federation of Square Dancers should create a Disaster Relief Fund maintained at no more than \$2,000 in order to help dance halls that are unable to afford necessary repairs in order to keep their doors open and supporting the dance community.

There was lengthy discussion regarding procedures for financial support for halls owned by clubs and if the By-Laws would need to be amended. It was decided that a Disaster Fund be set up for this purpose and would be defined under the Treasurer's responsibilities. Bruce Morgan moved to create a Disaster Fund for wholly owned square dance halls in the amount of \$2,000. It was seconded by Kathy McKinney. Said fund would supplement amounts not covered by insurance with a committee to be appointed to develop specific rules for its purpose. Payout would be a maximum of \$1,000 at a time. Motion passed. Committee appointees are Bruce Morgan, Jack Hoffman and Jenny Green.

Don Slocum presented valuable facility and flooring rental information and prices with suggestions that only the halls with Round Dance have flooring put down. There was much discussion on this recommendation though no decision made, it has been taken under advisement and the upcoming 2020 convention chairman will continue to further consider this.

Don also stated that this year we had some miscommunication on the amount of tables that would be needed for the various associations and future national conventions, etc... for displays and advertisements, that he requested to give careful consideration to this let him know well in advance how many tables will be needed, therefore please if you are interested in a table at the convention for any displays get with any one of "The Firm" (Terri Little/Cheryl Miller/Sheila Reid/Jenny Green/ or Shannon Reid) as soon as possible with the number you would like. Don did state that we can always request more if needed however it can be time consuming and confusing considering all that is happening on Friday morning at the Ocean Center therefore the more we can know and have done ahead time the more efficient we can be.

Susan Snider of The Round Dance Council requested that All Rounds be moved back to Rms 102 and 103 separate from the Square Dance Halls as they encountered sound difficulties this year. This is already being addressed for the upcoming 2020 convention.

Susan also inquired if the Round Dance halls could open and start dancing at 9am on Saturday as many of the dancers are coming across from the early morning Square Dance on the beach and wondering why there was no dancing. Continuing, she stated through observation only she has noticed Round Dancers tend to arrive earlier than Square Dancers. Again, the upcoming 2020 convention chairman will consider

further however at this time do not see why we could not implement Rounds beginning at 9am on Saturday.

Carol Poole, past Registration chairman, requested that the Information/Registration Desk be kept informed of any changes during the convention to potentiate effective communication.

Lastly, a sensitive subject we understand, however considering the changing times and increasing expenses, an important one which would be Complimentary Admissions, primarily regarding Callers and Cuers was brought to the floor. There was considerable discussion on this with some great ideas entertained, though no decisions were made.
